Thank you for your consultation dated 03 August 2015.

The Greater London Archaeological Advisory Service (GLAAS) provides archaeological advice to boroughs in accordance with the National Planning Policy Framework and GLAAS Charter.

Having considered the proposals with reference to information held in the Greater London Historic Environment Record and/or made available in connection with this application, I conclude that the proposal is unlikely to have a significant effect on heritage assets of archaeological interest.

This is because the site does not lie within an Archaeological Priority Area and as, noted in the desk-based assessment, it has low archaeological potential for all periods reflecting a paucity of recorded archaeology in the vicinity and its historical location within medieval open fields. The site will also have been disturbed by construction of the school. Whilst




some as yet undiscovered archaeological features could be present there is no evidence for a significant heritage asset.
