As requested, please find attached an excerpt from our accounting software showing rents received from Roger Cockram Services (RCS), LTC, Refuels Ltd and Tower Associates.

The software holds records from early 2014, following Certas Energy UK Limited taking control of the site in Q3 2013 / 14

Rent payments are generally identified with a payment code MTHOPRENT.

There are other payments and credits listed to the various tenants. This is because they have either bought products from Certas, been credited for works carried out across the site on behalf of Certas or had issues with the property they are occupying.
