The application site is an existing semi-detached dwelling house in lawful residential use (Use Class C3) and has not been subject to any enforcement action or planning restrictions that would affect its status. The proposed roof extension incorporating a dormer, is an alteration to the original dwelling house that fall within the allowances of Permitted Development under government guidance document. There are no Article 4 Directions or planning conditions restricting permitted development rights on the property. Therefore, the existing building is lawful, and the proposed works comply with national planning legislation for permitted development

I consider that a lawful development certificate should be granted for this proposal because the works fall within the parameters set in the relevant guidance documents. The proposed rear dormer, complies with the size and design limitations under the relevant Class's. Furthermore, there are no relevant restrictions, such as Article 4 directions or planning conditions, that would prevent the works from being considered lawful. Based on these factors, I believe the proposal meets the criteria for permitted development and should be granted a Lawful Development Certificate. Although we acknowledge each application is assessed on its individual merit we can confirm that there has been a significant number of similar alterations, including the two neighbouring properties.
