T1 + T2 Alder - ///flops.tens.vent - Cutback any branches overhanging into neighboring property back to the boundary, approximate lateral reduction of 1-2m varying.

T11 - Apple - ///grab.gossip.plugin - Cutback any branches overhanging into neighboring property back to the boundary and remove all visible deadwood.

T12 - Apple - ///flies.than.colleague - Cutback any branches overhanging into neighboring property back to the boundary and remove all visible deadwood

T13 - Prunus - ///barn.poker.work - Cutback any branches overhanging into neighboring property back to the boundary

T14 - Holly - ///barn.poker.work - Cutback any branches overhanging into neighboring property back to the boundary

T15 - Prunus - ///first.admiral.drew - Cut back any branches overhanging into the neighboring property to the boundary

T16 - Acacia - ///flat.mostly.spray - Cut back any branches overhanging into the neighboring property to the boundary excluding main lateral branches, only sublateral and beyond growth should be removed.

Reasoning for works, the client would not like their tree's to interfere with neighboring properties and the eventual possibility to cause damage. By carrying out the work sooner than later the tree's will be more manageable in the long run and more cost effective to keep maintained.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
