The application proposes to replace the existing shop frontage with a new shop frontage with minimal structural differences. The existing shop frontage is formed in a timber framed glazing which is inconsistent with a large number of units along Field End Road and the surrounding area. In addition the timber has lost structural integrity to the point of instability with an awning that is in disarray. The new façade will be formed with an aluminium framed glazing to replace the existing installation and so fundamentally improves the current aesthetic. In addition the awning will be removed completely. The central door position will be moved to the right to allow a larger expanse of glass frontage. The upper sections of the main façade and surrounds will remain untouched. The streetscape has a variety of styles and finishes to which there is no consistency and is fairly typical of a retail high street. Opposite to the property, the majority of the shop frontages utilise aluminium framing with large sections of glass. The proposal will not adversely affect or diminish the quality of the elevation or overall street scape. As such, the proposal complies with the NPPF. The attached photos are a few examples of shop frontages that have aluminium framing and a door to the far right or left along Field End Road
