Clarification: Biodiversity Net Gain (BNG) and De Minimis Criteria The proposed development at Boots Opticians, 33 High Street, Ruislip involves the replacement of the existing shopfront and front entrance door only. The works are entirely restricted to the building façade, with no external ground disturbance, demolition, or landscaping changes. As such, the proposal: Does not result in any loss or alteration of existing habitats (no soft landscaping, planting, or soil disturbance involved). Is wholly contained within the existing built footprint of the property. Does not trigger the requirement for a Biodiversity Net Gain assessment under Schedule 7A of the Town and Country Planning Act 1990 (as amended).
