## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 - Hornbeam - Fell/Remove - Old coppiced tree not in great health, rot present at the base and at the top main stem.  
T2 - Hornbeam - Fell/Remove - Old coppiced tree leaning heavily as its trying to get light and it's under a much bigger and healthier tree. also noted presence of rot at the base so we believe removal would be best option.  
T3 - Hornbeam - Remove a limb and a 4-5 metre lift. Limb comes out very low and looks messy. removal would allow better use of the space and let light trough.  
T4 - Hornbeam - Fell/Remove - Young sapling growing pretty much as understory- under the big trees is never going to turn into anything significant as it's just in the wrong place.  
T5 - English Oak - Crown reduction by 2 to 3 metres, thinning and deadwood. Crown reduction and thinning would allow light trough the garden and aid tree's health.  
We believe the proposed work would greatly benefit the garden and surroundings as of for now they're just fighting each other and very limited amount of light is able to penetrate.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
