The extension comprises a L shape side infill and rear addition which replaces the attached rear WC. The scheme envelope is primarily a mirror of the approved extension at 17 Money Lane (London Borough of Hillingdon reference 24183/APP/2020/3438). To enable the roof proposal, a first-floor window is proposed to be infilled, with an alternative skylight window for the first-floor bathroom proposed in the main roof rear pitch.
