Having considered the proposal with reference to information held in the Greater London Historic Environment Record and the files provided for this application, I conclude that the proposal is unlikely to have a significant effect on heritage assets of archaeological interest.

Although the site lies in areas of archaeological interest (Harlington Archaeological Priority Area and the Heathrow Area), the development is too small scale to have a significant archaeological impact. GLAAS will not need to be consulted.
