Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Large Oak tree located between Number2 Hollycroft and Sipson Rd located within TPO 263

The tree is of a significant size and age with an approximate height of 21m and a crown spread of 22m.

The trunk girth at 1m from ground level is approximately 1.2m across.

The Western side of the canopy is overhanging the building line of n.o.2 and is in contact with the pitched and flat roof.

I advise the reactive growth growing towards the property are reduced back to where they originate at the historic pruning points and the remaining tertiary growth of the lower crown is reduced back by up to 2.5m to suitable growth points to give a minimum clearance of 2m to the building line.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
