Details of the pre-application advice received

1. Nothing at first floor level is so far forward in the street.
2. Pulling the first floor over the existing GF bays makes the footprint oversized and results in the creation of a crown roof where these are not characteristic.
3. The side flank next to no.64 would be considerable and very exposed.
4. The scheme before us seeks to keep and respond to the GF footprint however, this is much larger than any 2 storey dwellings by virtue of being a bungalow. If you want two storeys – you will need to relate to the footprint and roof form of others nearby.
5. Please can you provide some photos from rear to understand amenity impact. We particularly need to see any side windows of neighbouring dwellings facing your site.
6. We also need a block plan which shows a 45 degree line of sight from neighbouring first floor windows.
