




Section CC, showing steps and hand rail details



Section BB, showing steps and hand rail details


Section AA, showing ramp and handrail details



Part Plan Front Area, showing location of Section AA, BB & CC.


Typical Ground Floor Plan


Roof plan



Front Elevation on Arrow C




Front Elevation on Arrow B
