T1. Beech Tree See Map

Adjacent to no: 37:

Reduce back lateral spreading branches to clear property by 3.5m, ensuring all pruning cuts to suitable points.
Remove dead branches.

(Routine Maintenance)

The tree's current height is 23m and crown spread is 19m
After the proposed works, the tree's height is 23m and the crown spread is 15.5m (Not Radial) just the side of the property.

T2. Monterrey Cypress See Map/North Boundary:

Remove damaged/broken and hung-up limb.
Inspect the crown for adversities and remove large unstable dead branches.

(5 Days Notice see pictures attached)

(Routine Maintenance) and to remove the dangerous hanging branch.

T3. Lime

See Map/Front Northeast corner of the site:

Remove dead branches over 3cm in diameter.

(Routine Maintenance)

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
