Conclusion

In overall terms the proposed development is considered to have a greater impact upon the openness of the Green Belt in terms of its width, depth and overall footprint and would therefore as currently presented be defined as inappropriate development. Further information and/or reduction in built form is required.

The design is not supported. Any new dwelling should be a modern interpretation of the traditional 1930s design that is prevalent in the area and should reflect the existing characteristics of the site.

No Basement Impact Assessment has been submitted at this stage to demonstrate that the proposed development is acceptable in relation to flood risk.

The site is not the subject of a Tree Preservation Order and is not located in a Conservation Area.

However, the proposed development would increase the built form of the site and there are a number of mature trees close to the site boundaries that would appear to be affected by the proposals. A tree survey, tree report and arboricultural impact assessment to BS5837:2012 should be submitted with any future application to identify and assess all of the trees which influence, or may be influenced by, the development including off-site trees.
