Adam,

Thank you for your e-mail.

Regarding the points you raise I can confirm as follows:-

Location and projection limits – any restrictions if the structure is close to a boundary or faces a highway.-Any application will be assessed in terms of it's visual impact on the street scene and Conservation Area. Each case is assessed on it's own merits taking into account the streetscape.

Height and dimensions – maximum permitted height and overall footprint.-Subject to the scale of the host dwelling but 3m is a normal height for an extension-to eaves.

Materials and finishes – any preferred or restricted materials for external surfaces.-Glass is not normally too offensive allied to finishes similar to the main house.

Permitted development considerations – whether any part of the structure may fall under permitted development rights, and if not, what information is required for a full planning submission.-Being to the side/front of a house adjacent to a highway always requires planning permission.

Supporting documentation – any specific plans, reports, or surveys recommended to accompany the application.-Any submission would require a short Heritage Statement.
