Details of the pre-application advice received

In its current form, the proposal would not be supported by the Council. The principle of the development could only be accepted if the proposal addresses the identified concerns.

Significant concerns exist that the proposed development would unduly harm the character and appearance of the building and Conservation Area. The design of the amendments to the existing dwelling, on the whole, would not be supported due to eroding, obscuring, and losing the original character and features of the dwelling that contribute to the conservation area's character. The new dwelling relates poorly to the original dwelling, is overly large and tall, dominates the original dwelling, and fails to complement or enhance the conservation values of the original dwelling, thereby harming the character of the surrounding conservation area.

In addition, concerns have also been raised as the proposal would provide substandard internal amenity for the future occupiers of the existing dwelling due to insufficient space. The size and location of the proposed outbuildings would unduly impact the residential amenities of neighbouring sites.

There are also concerns that trees of merit and high visual amenity value would be lost.

The proposed development would, therefore, conflict with national, regional, and local planning policies and guidance and could not be supported by the Council in its current form.

The scheme was subsequently amended to address all comments
