Details of the pre-application advice received

The advice relates to an enforcement case, the works were completed without Planning Consent, as the applicant was not aware that such landscaping works were subject to Planning Consent. A complaint was received by the Council and an enforcement officer was assigned. Officer Natasha Rozanski, who no longer works at the council, corresponded with the applicant in September 2019 and visited the site, along with a Tree Officer who deemed there to be no impact on trees. Following the site visit the officer requested additional photos and was offered a further visit, she did not take this up and did not correspond any further with the applicant who assumed her to be satisfied and the matter to be closed. It has recently come to his attention that it has not been closed and he has been advised by a different officer, Marsha Kange, that the works are subject to Planning Consent as they are deemed engineering operations, and approval should be sought. It is worth noting that when an application or Planning Consent was submitted after the completion of the landscaping work 14787/APP/2021/2528 no reference was made by the officer to the enforcement case.
