LONDON BOROUGH OF HILLINGDON TEMPORARY PROHIBITION OF TRAFFIC (VARIOUS ROADS HILLINGDON BOROUGH) ORDER 2026 ROAD TRAFFIC REGULATION ACT 1984 SECTION 14(1)

- Hillingdon Council gives notice that due to water mains replacement works to be carried out by Affinity Water and to prevent the likelihood of danger to the public it intends to make this Order, which will temporarily close:
 - Breakspear Road South (Service Road 64-114 Cophall Road West), Ickenham
 - Cophall Road West, at its junction with Breakspear Road South, Ickenham
 - Breakspear Road South (Service Road 2-42), Ickenham
 - Greenacres Avenue, at its junction with Breakspear Road South, Ickenham
- Diversion route will be in place via:
 - None
 - St Georges Drive, Greenacres Avenue, diversion ends
 - None
 - St Georges Drive, Cophall Road West, diversion ends
- Nothing in the Order shall apply to prevent vehicular access to premises on or adjacent to the prohibited length of road insofar as access is reasonably practicable without interference with the said works.
- The temporary restriction will be in operation between:
 - 08:00hrs on the 30th March 2026 to 17:00hrs, on the 27th May 2026
 - 08:00hrs on the 30th March 2026 to 17:00hrs, on the 27th May 2026
 - 08:00hrs on the 16th June 2026 to 17:00hrs, on the 24th July 2026
 - 08:00hrs on the 16th June 2026 to 17:00hrs, on the 24th July 2026and to such extent as indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2016. Road users should assume that the closure has been put into effect only if traffic signs have been erected stating that the road has been closed and the diversion route, if necessary is in place.
