Details of the pre-application advice received

Following my inspection of the extensions at 143 Long Lane, Hillingdon, there would appear to be a number of discrepancies between what was approved under 14904/APP/2024/1564 & 14904/APP/2023/3026, compared to what has actually been built. These include:

The ridge line of the roof was shown as stepped on the front elevation of 2024/1564, with the left being lower than the right, whereas they are the same

There is a central ridge running from front to back, which was not shown on the approved drawing of 2024/1564

There is a pitched roof (dummy pitch) to the single storey side extension to the left hand side as viewed from the road, whereas the approved drawings show a flat roof.

The first floor side window facing No.145, is openable below 1.8m above finished floor level, which is a breach of condition 4 of 2024/1564

There are two rooflights in the side roofslope facing No.145, which is a breach of condition 5 of 2024/1564

A single storey rear extension (and canopy roof) has been built which is not shown on any approval

Air-conditioning units have been installed, which are not shown on any approval

In order to regularise these matters your client can either alter the extensions so that they comply with the planning permissions granted and in particular 14904/APP/2024/1564 or submit a revised planning application in an attempt to retain the discrepancies as built. Please note however, this email does not mean that if an application were to be submitted that it would be granted, only that it would be considered on its merits and with due regards to both local and national policies.
