- At least 200mm from the eaves.
- Volume increase of no more than 50m³.
- The materials used for the conversion will match the existing property

Complies with Permitted Development rights under Class B and Class C of the General Permitted Development Order 2015. The volume increase is within the 50 cubic metres limit for a semi-detached property, and the dormer is set back 200mm from the eaves, with no impact on the ridge height. The property is not in a conservation area or subject to any Article 4 Directions, and the materials will match the existing structure. Therefore, the works fall within the scope of lawful development.
