N.B. All of the trees within this application are less than 40 years old and therefore not part of TPO 391 that was implemented in 1986. However, the owners of 3 Linksway have had building works completed and within the planning conditions, the retained trees were mentioned. I have attached the planning conditions please see paragraph (7).

G1:

This consists of 14 x Thuja. 7 of them are planted in the front garden of 1a Linksway and 7 of them are planted in the front garden of 3 Linksway.

This application is to remove them all. The brick boundary wall between the properties is being damaged by the trees as well as the brick work between the boundary wall and the structure of 3 Linksway. Photos are attached.

These trees have not been managed and are now too large and causing damage to property. The intention of 3 Linksway is to replant an indigenous hedge in their front garden to replace this non-native, overgrown hedge.

G2: Removal to ground level of 5x Cypress along front boundary with roadside. Trees are not providing the screen that they were planted for and are now preventing the growth of the beds beneath them. They are also suppressing the healthy growth of the large Oak next to it (Hillingdon Council tree).

I'd like to reiterate, it is my understanding that none of the trees within this application are subject to a TPO because they are too young (planted after 1986). This application is to make sure that we are not in breach of planning.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
