The proposed works — comprising a hip-to-gable roof extension, rear dormer window, and installation of rooflights to the front roofslope — comply with the conditions and limitations set out under Schedule 2, Part 1, Class B and C of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended). The proposal remains within the maximum volume allowance for roof extensions, is set back appropriately from the eaves, does not exceed the height of the original roof, and uses materials similar in appearance to the existing house.
