The proposed development comprises a hip-to-gable roof extension, rear dormer, 2 front rooflights and 1 obscure-glazed side window within the gable wall. The proposal complies with the conditions and limitations of Schedule 2, Part 1, Classes B and C of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended). The proposed roof enlargement remains within the permitted volume allowance for a semi-detached dwelling and does not exceed the height of the existing roof. The side window will be obscure glazed to protect neighbouring amenity. Accordingly, the proposed development constitutes permitted development and a Certificate of Lawfulness should be granted.
