The existing plans require a foundation to be placed where the sewer is located. Furthermore, the builder informed us that it would be very difficult to seal the existing conservatory onto the building wall most likely causing future problems.

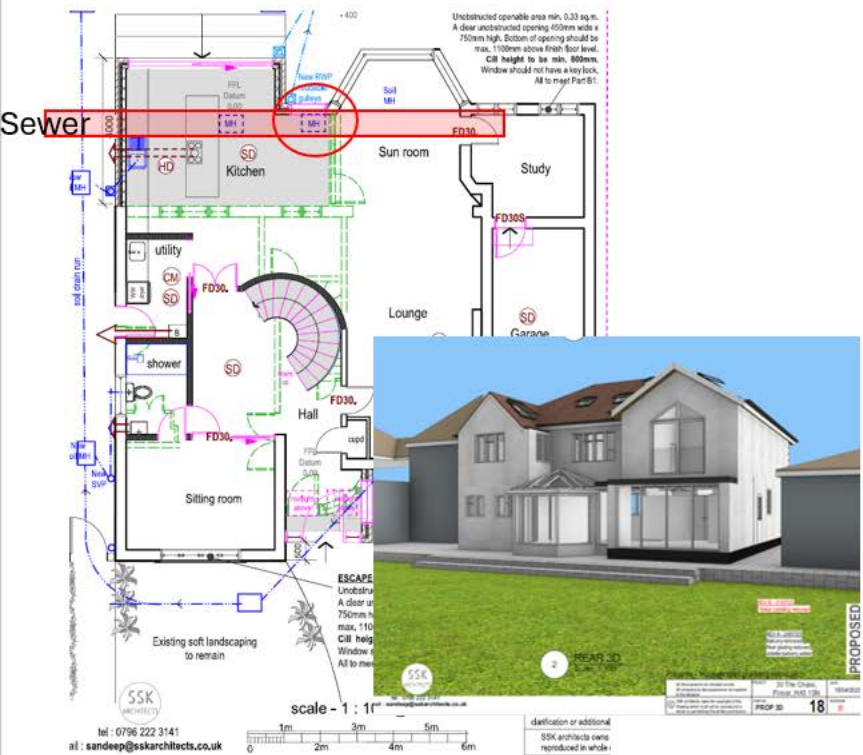

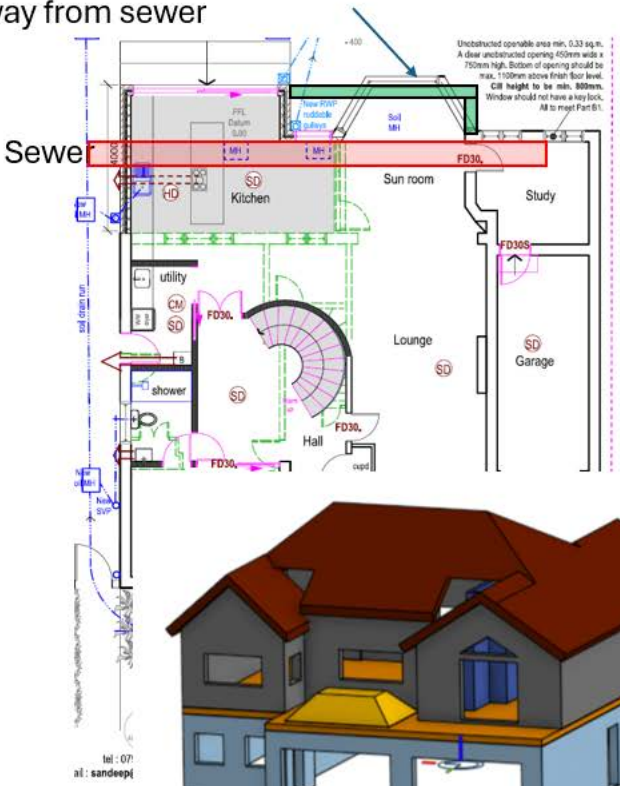
