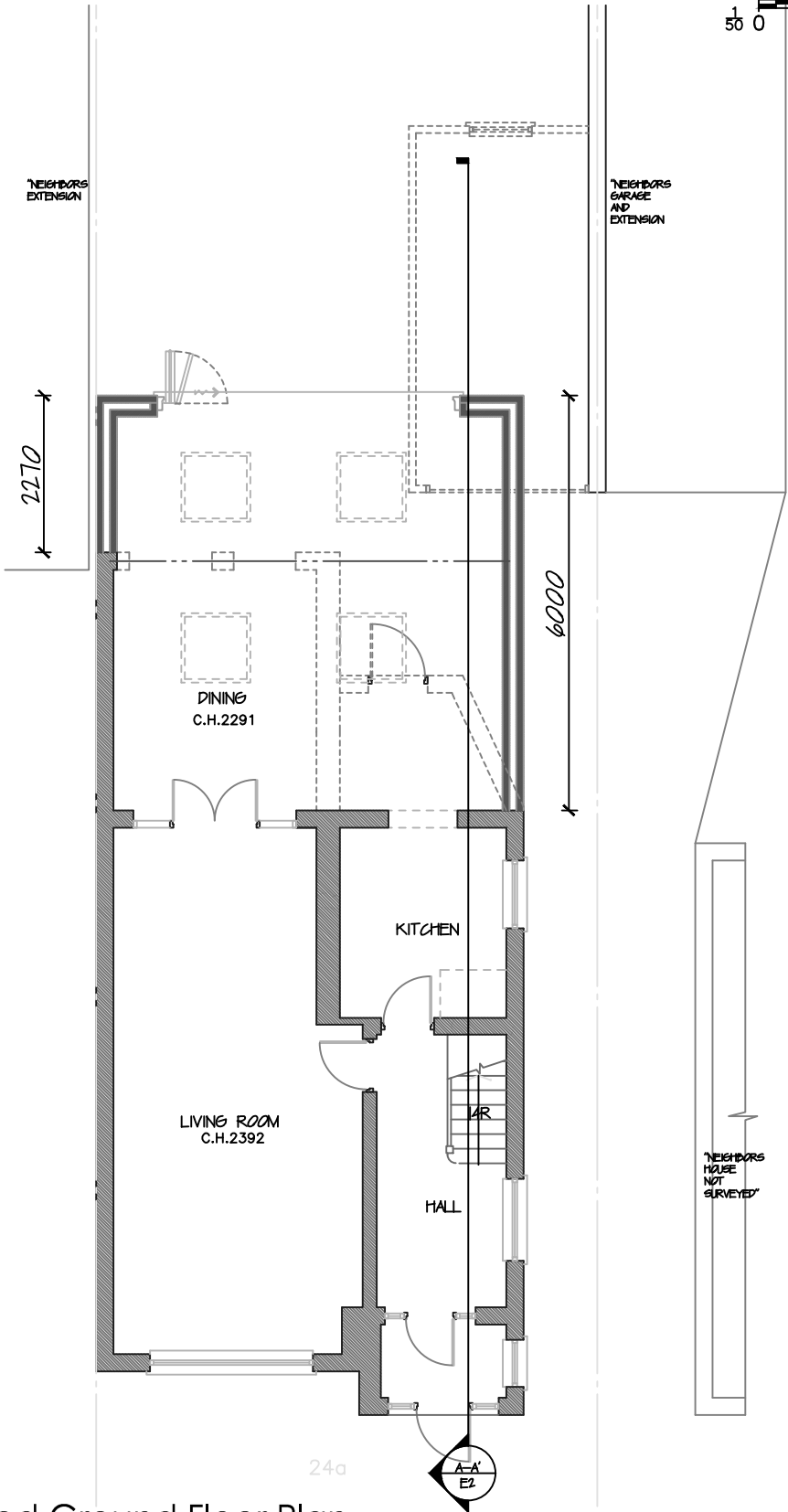


Existing Ground Floor Plan

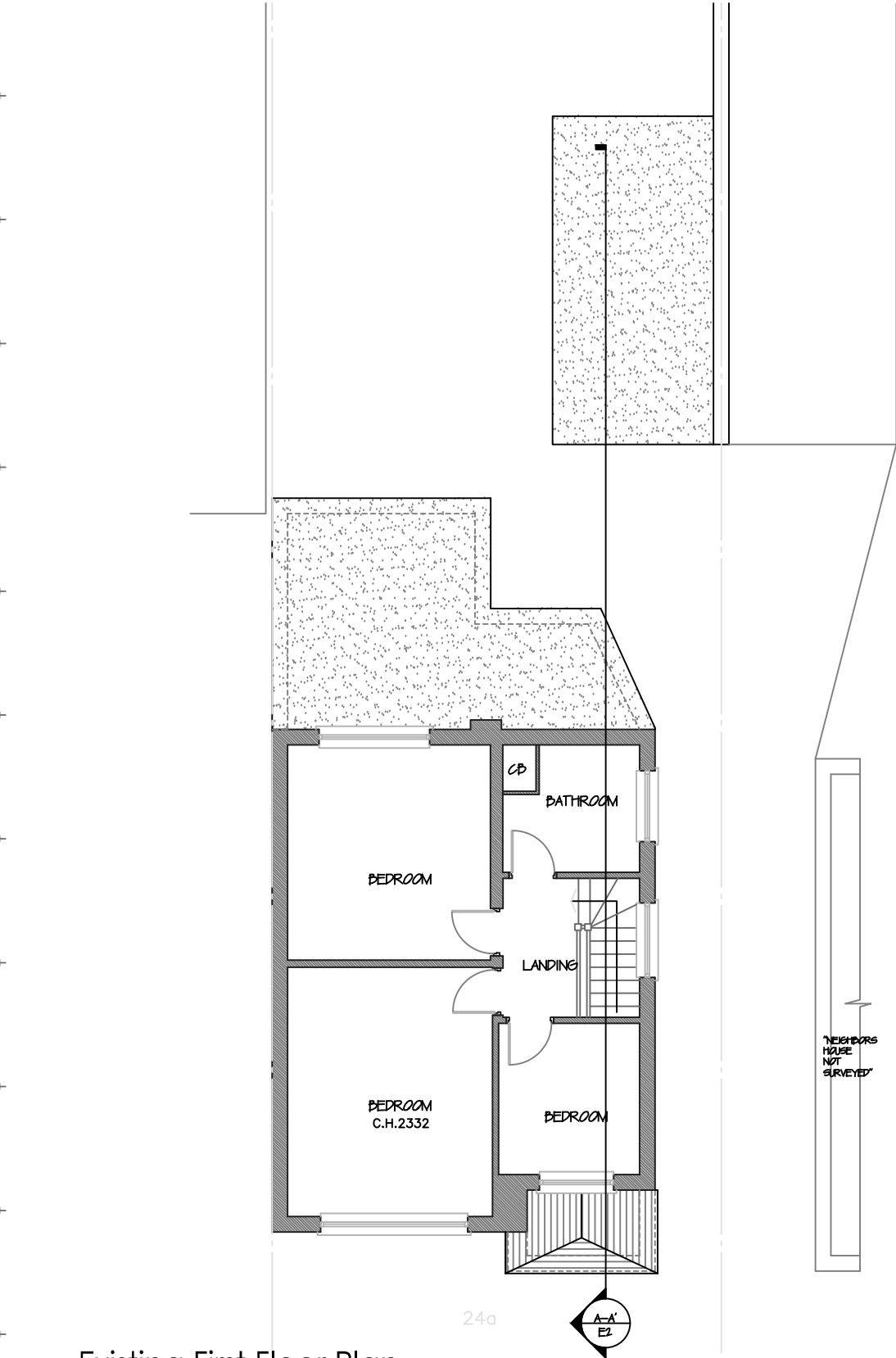
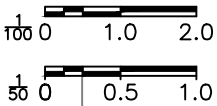

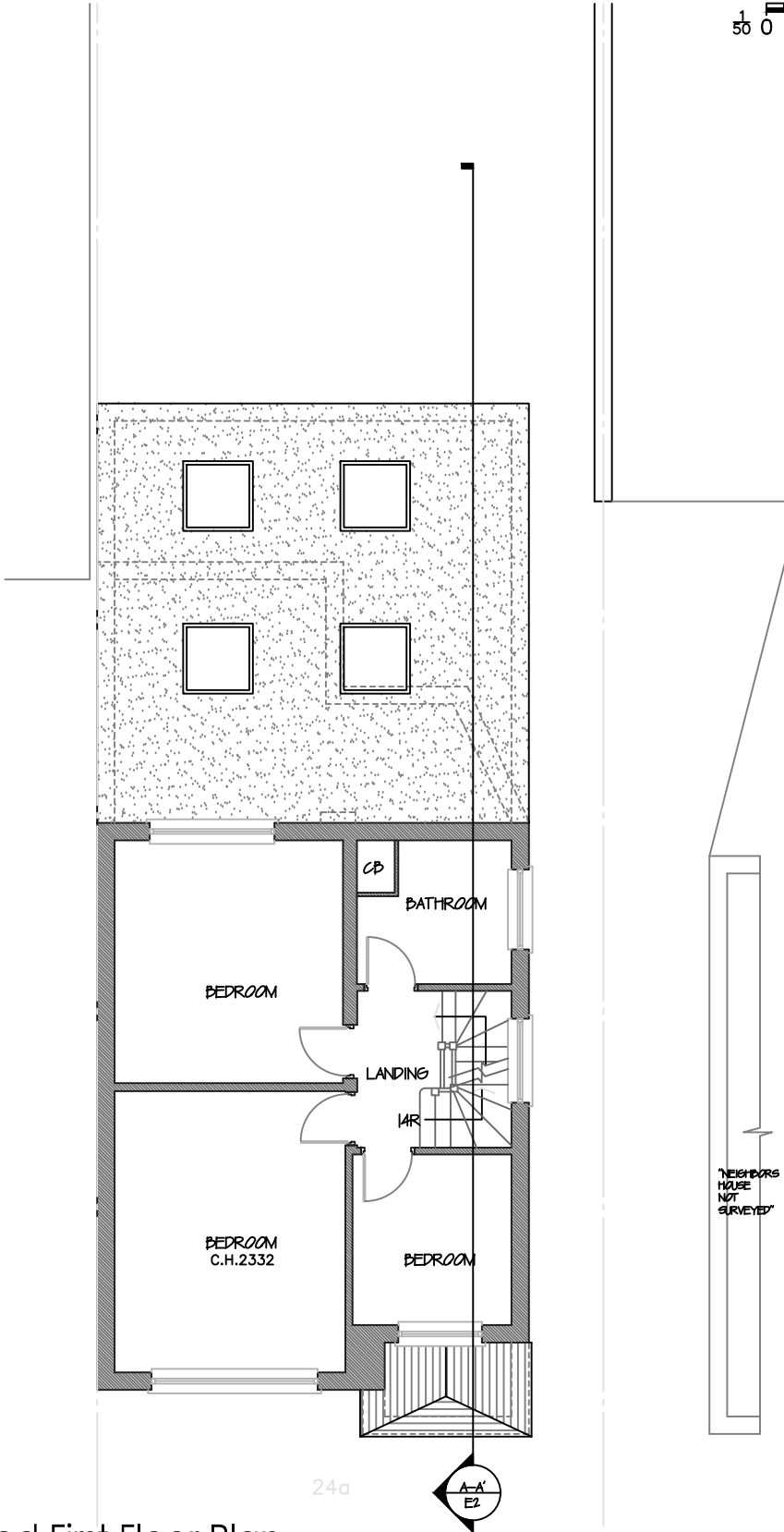


Existing First Floor Plan
