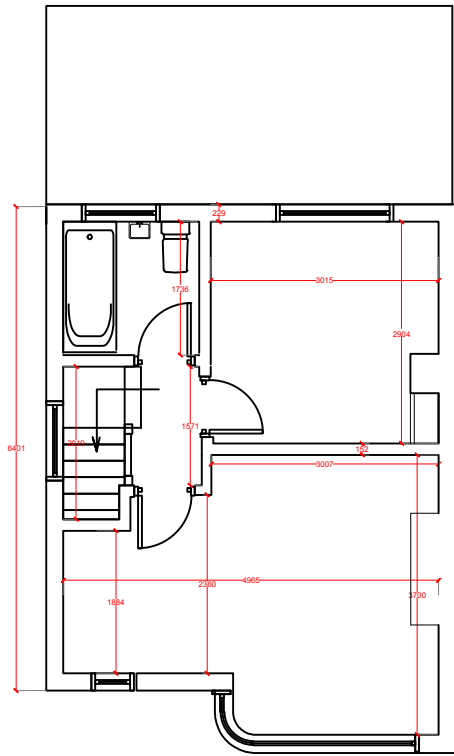
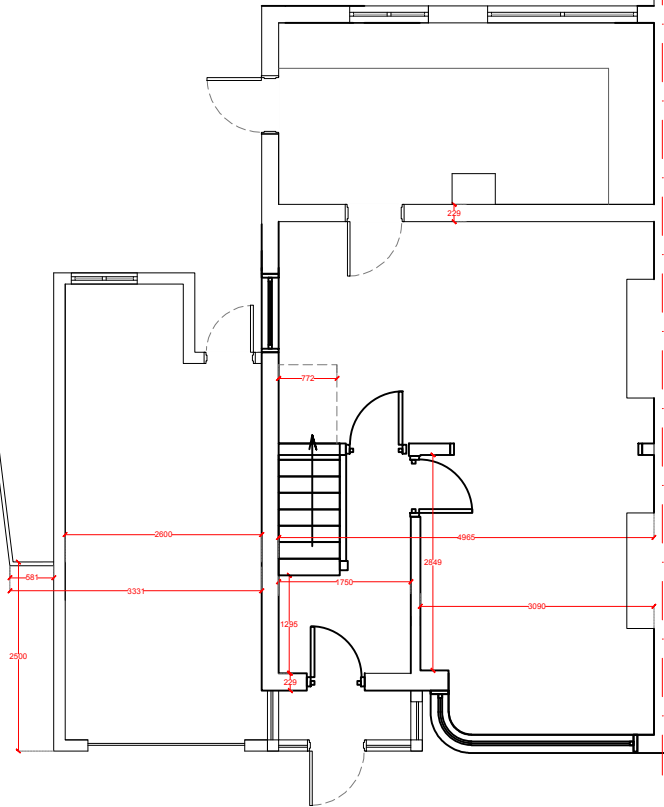


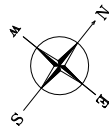
(R) EXISTING ROOF PLAN

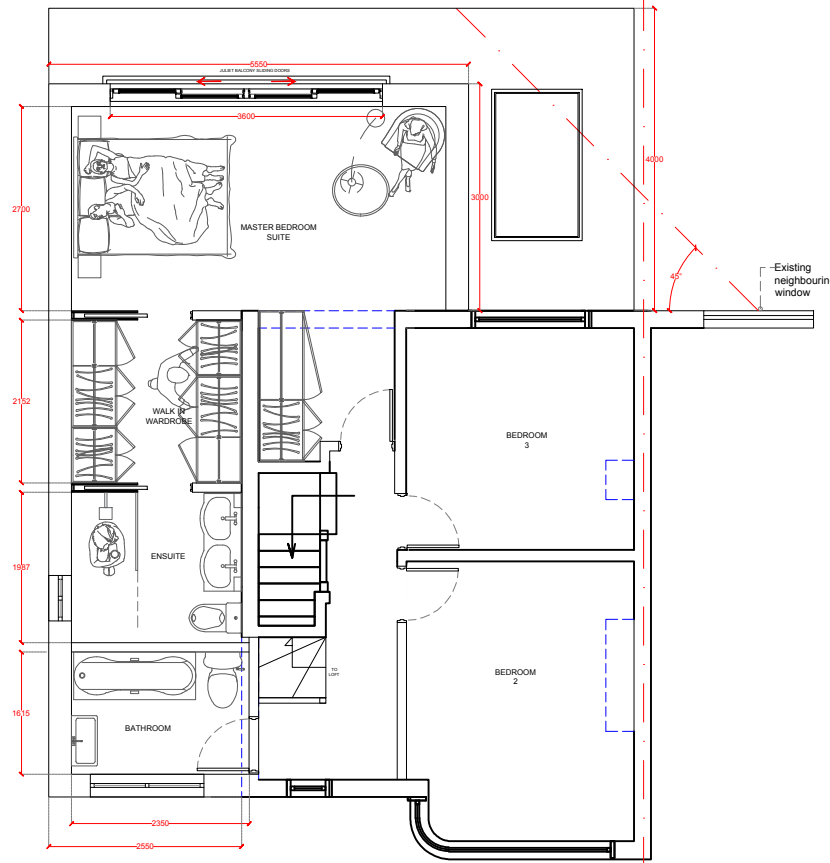

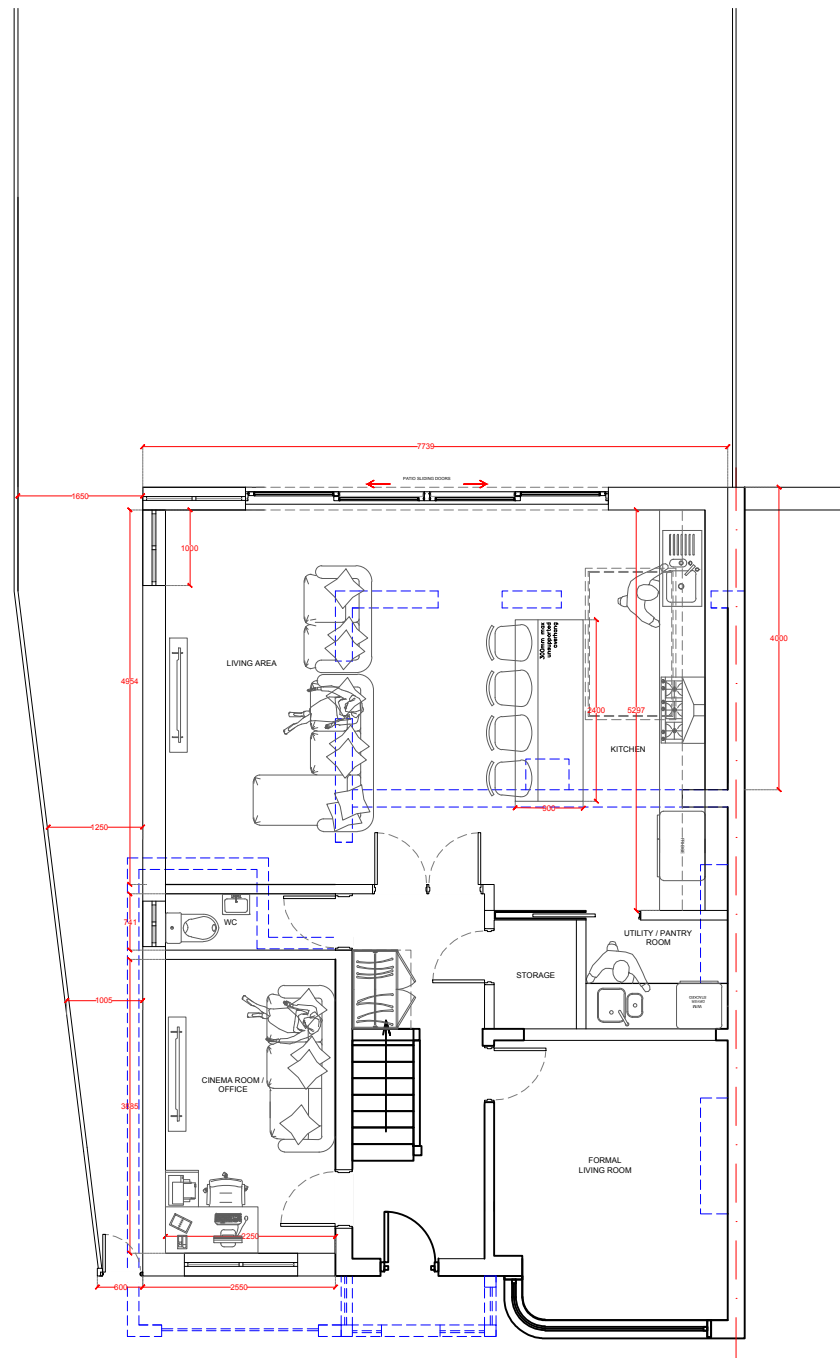

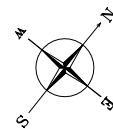
(L) PROPOSED LOFT PLAN

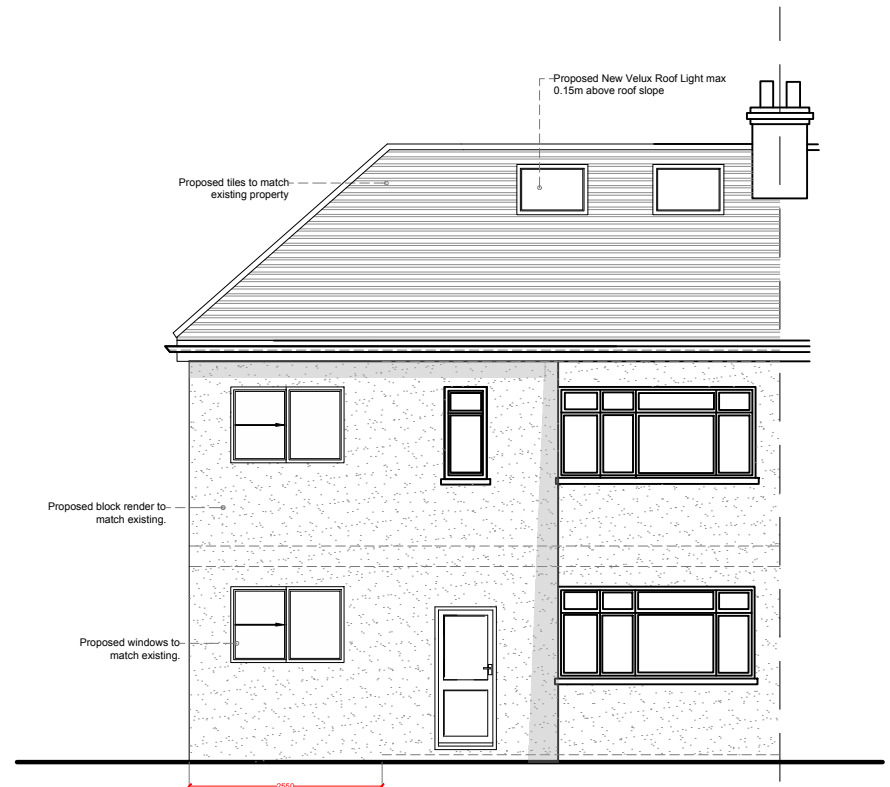

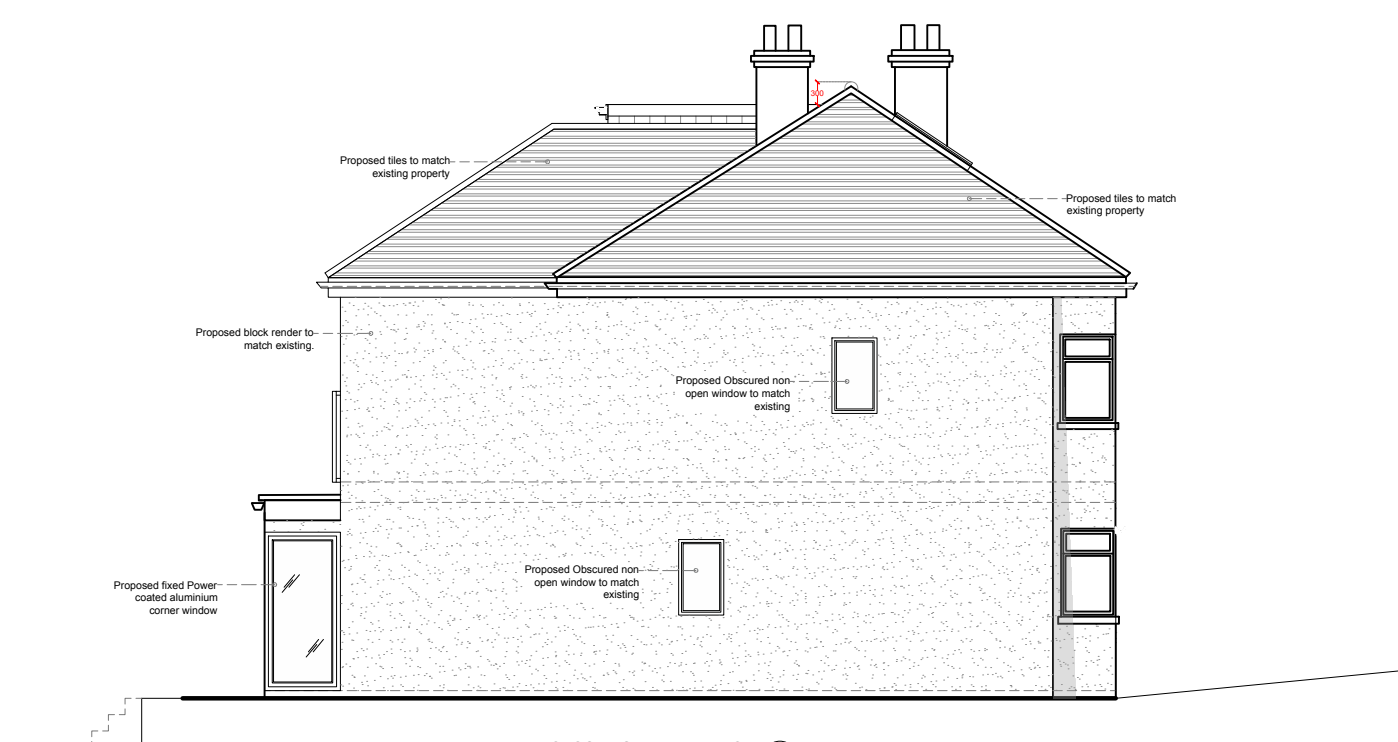

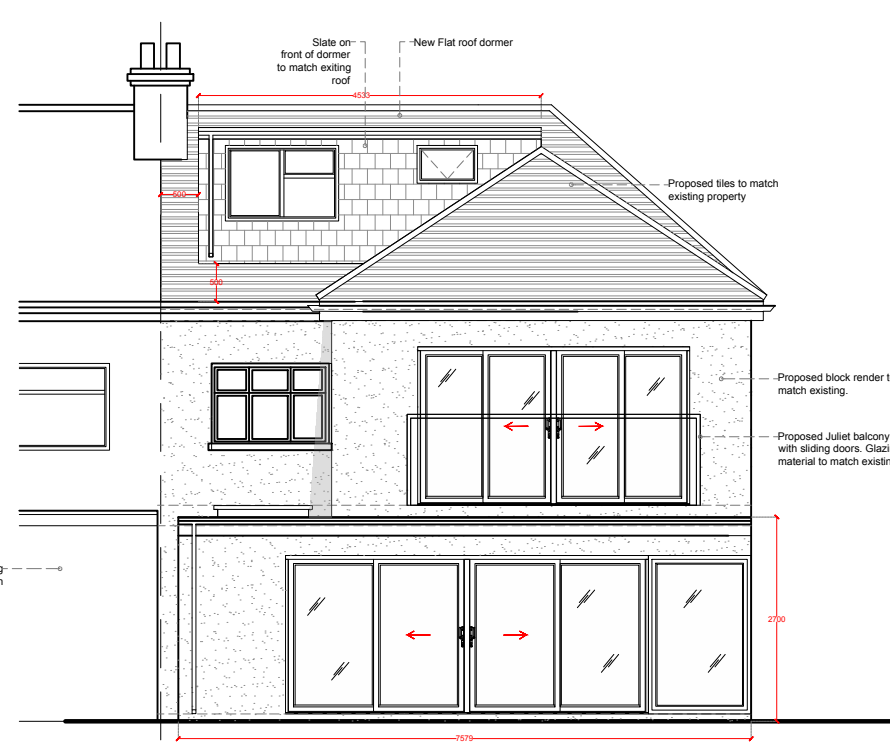
PROPOSED SIDE ELEVATION S

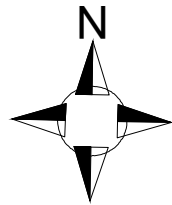

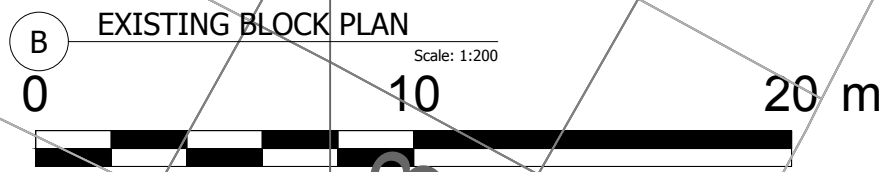


SL SITE LOCATION PLAN

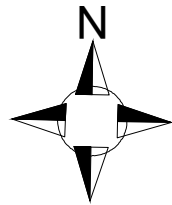

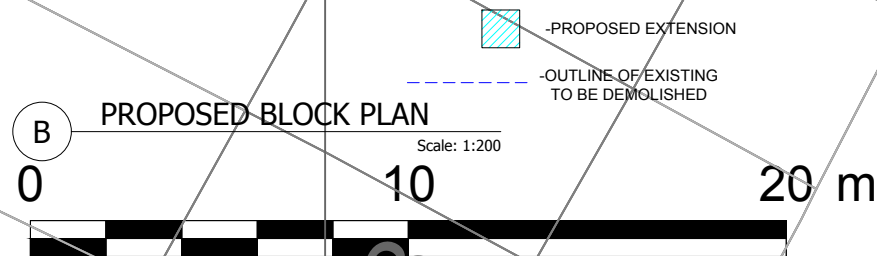


SL SITE LOCATION PLAN
