Details of the pre-application advice received

Advice given as follows

'I would suggest a slightly narrower flat roof dormer each side would be best. As the eaves height appears to match that of the neighbouring bungalow, the ridge height should also be lowered to match. I would also suggest adding a small window into the blank dormer. This would all allow the development proposal to pair up better with the neighbour.

I note both neighbours have either a dormer and rooflights or side windows facing into the application site. Therefore we would likely obscure glaze by condition any side facing dormer windows to avoid inter-visibility.

It would be useful if a street section were provided with any future application to allow us to see how the proposal would fit in within the street scene of the conservation area'
