The existing outbuilding has a footprint of 65.64sq.m (11m deep x 5.92m wide) and is currently used as a granny annex, a use incidental to the main dwelling. As noted in the principle section of the report, there is no recent record of permission granted for this outbuilding. It is advisable to provide details demonstrating the existing building is in situ for over 4 years as part of your submission.

The existing outbuilding would be removed along with the additional existing outbuilding which are located along the shared site boundary with 5 Nicholas Way. The proposed outbuilding would have a footprint of 67.99sq.m (12.10m deep x 5.62m wide), would be constructed from timber and would be the same height as the existing outbuilding (to be removed). Officers would raise concerns regarding the overall scale and size of the replacement building. Whilst it is noted that it would involve a modest increase on the existing building, there is no record of permission for this existing building. Hillingdon policies generally tend to restrict outbuilding floorspace to 30sqm. It is advisable to consider reducing

the overall scale of this outbuilding. Whilst the use of timber finish and the set-ins from the site boundaries would be supported in the back garden setting, the overall height, scale and footprint should be modest or reduced from the existing building size. It is evident from the sectional drawing provided that this scale is significant in the garden. At application stage, Officers would advise to reduce the scale to below the existing building or provide justification that the footprint would not harm the wider Copsewood Estate Area of Special Local Character. The proposed replacement outbuilding would be used for purposes incidental to the main dwelling and a condition preventing non-incidental use of the outbuilding would be included on any consent granted.
