The the existing building is a block of 10 flats. The planning permission ref 17011/APP/2014/3594 for nine flats was obtained in 2015. The works were carried out subsequently. The existing penthouse (flat no.9) was sub-divided to provide a new 1 bedroom flat no.10 which is in continuous existence for more than four years. The flat is continuously occupied by the same tenant since December 2017.
