Details of the pre-application advice received

The proposed development would result in a loss of 136m2 of retail storage space. The loss of the space could reduce the ability of the ground floor retail unit to function, ultimately leading to the loss of the retail unit. Loss of the retail unit in this town centre and primary shopping area location would not be permitted and would not support the Development Plans aims of encouraging and supporting commercial uses in order to safeguard the vitality of town centres. As such an in principle objection is raised. Any future application should be submitted by robust justification which evidences that the proposed change of use would lead to no loss of the ground floor retail unit, nor would it significantly reduce its chances of longevity.
