T1 tulip tree on TPO611

to carry out tree surgery including crown reduction by 20-25% to include a reduction in height by 2-3m to one tulip tree T1 on TPO611. This work will protect the health of the tree and will fit in with visual look and amenity of the area.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
