7. Identification Of Tree(s) And Description Of Works continued ...

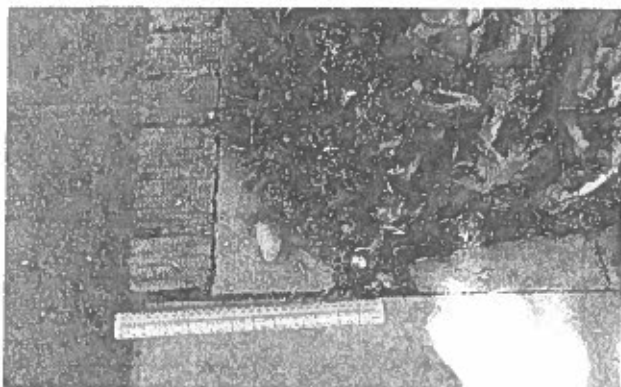


Figure 4 Retaining wall displaced by 20 mm.

The subject of this application is a yew tree in the rear garden of 41 Frayslea. This tree is the smallest of 11 mature yew trees on the Frayslea estate. The general situation is shown in Figure 1. The tree is higher than the house (approximately 6.8m to the ridge tile) and touches the wall. The trunk of the tree is 4.3m from the house and 1.7m from the nearest of the three garages behind the tree in Figure 1. The tree suffered a severe pollard shown in Figure 2 prior to possession of property by the current owner. Cracks are appearing around the yew tree in the path between the tree and the garages shown in Figure 3 and the patio shown in Figure 4. The tree has two large bracket fungi that appear in the autumn. The house at 41 Frayslea and trees behind the house on council land obscure the view of the tree from other houses in Frayslea. The application is to fell the pollarded yew tree because:

- 1) there is a risk to buildings beyond the path and patio; and
- 2) the tree has low amenity value.

A cypress tree hedge shown on the left in Figure 1 has had three trees suffer disease and these have been replaced with yew trees. If any other cypress trees suffer disease then the proposal is to replace them with additional yew trees.

This application is supported by the owners of the three garages shown in Figure 3 behind the tree.

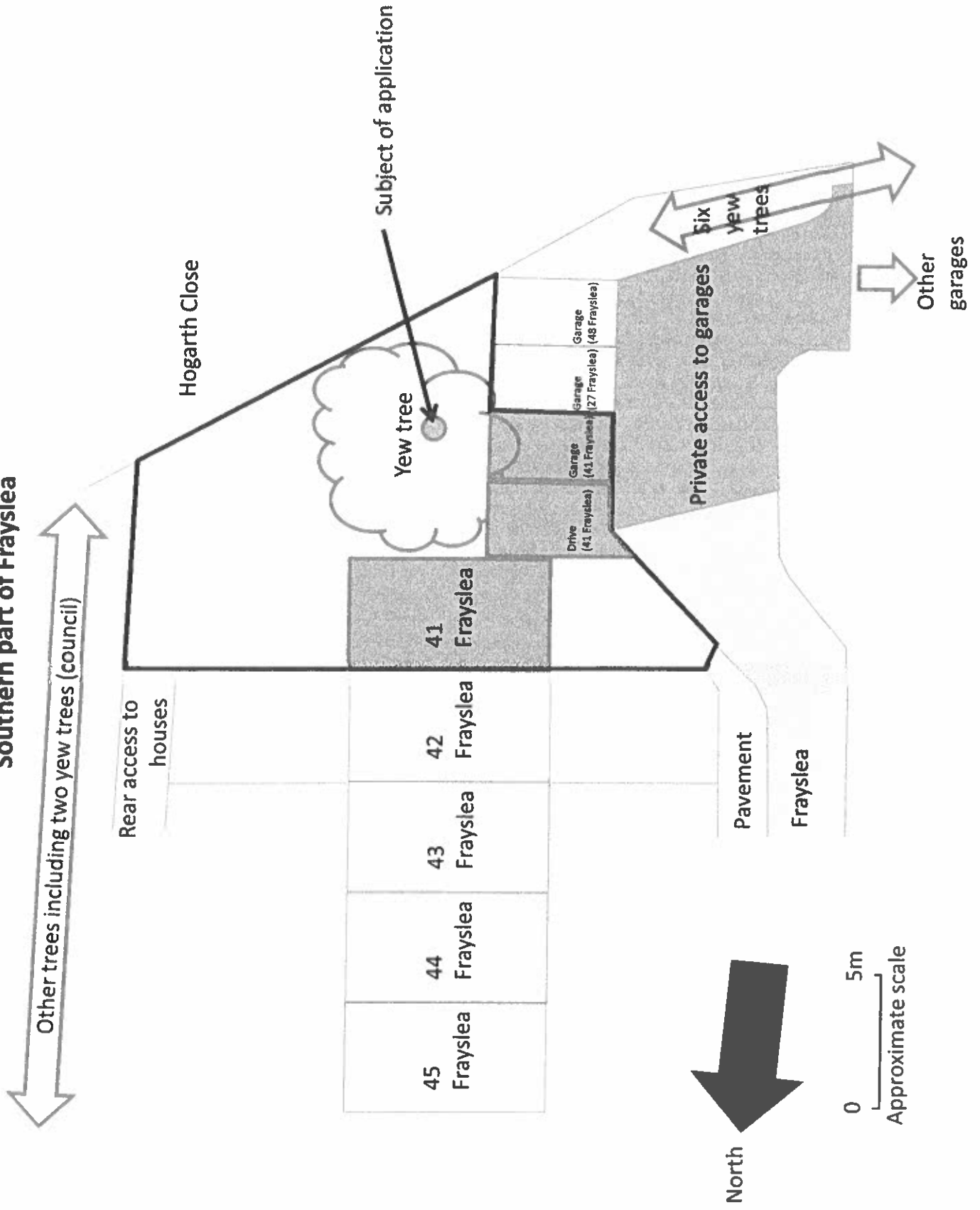
