The application is for a Certificate of Lawful Development for the conversion of the roof space to habitable use to include a rear dormer window, 2 front roof lights and the conversion of the roof from a hip to a gable end, with a new gable end window.

The proposal clearly involves development as defined in the Planning Acts. No conditions have removed permitted development rights for this proposal, nor is there an Article 4 Direction restricting this type of proposal.

The proposed conversion of hip to gable end is an increase of 12.84 cubic metres. The proposed dormer window has a volume of 28.36 cubic metres. The plans also indicate that the roof conversion would:

- i) Be no higher than the existing roof line.
- ii) Not extend beyond the plane of an existing roof slope which forms the principal elevation of the dwelling which fronts a highway.
- iii) Not exceed 50 cubic metres. (semi-detached property)
- iv) Not include a veranda, balcony or raised platform.
- v) No confirmation that the roof lights would not protrude more than 150mm beyond the plane of the slope of the original roof . CONFIRMATION HAS NOW BEEN GIVEN VIA NOTE ON DRAWING
- vi) Have side windows obscurely glazed and non opening below 1.7 m.
