Details of the pre-application advice received

In conclusion the proposed new shopfront, including awing, shutters and fascia sign would be considered acceptable in visual terms. Despite this, there are concerns with the projection sign in terms of its internal illumination and its siting, overlapping with a neighboring projecting sign which result in clustered appearance to the shop front, resulting in harm to the character and appearance of the application site and wider conservation area, contrary to Policy DMHB 4, Policy DMHB 13 and DMHB 13A of the Hillington London Plan: Part Two - Development Management Policies (2020).

It is recommended that the scheme be amended in accordance with the requirements noted above in order to increase the likelihood of a favourable decision being made as part of any forthcoming planning application submission.
