Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The tree is a Norway spruce and is situated in the garden of my neighbour, David Hutton, at 22, Tudor Way. The spruce is 17 metres high, towers over both my house and the house at 22 and there is evidence of its roots spreading into my garden which has led to the blockage of a drain in recent months. There are some signs of cracking in the nearest wall of my house. The paving stones in part are also being pushed up by the tree's roots and constitute a tripping hazard for anyone venturing into the back garden. I am concerned that there is a risk of the tree coming down in a high wind which would present a possibility of it falling either onto my own house or to the house at 22. The garden in 22, Tudor Way has a number of other trees already including an old Oak tree to the rear of the garden. I am therefore applying for the complete removal of this tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
