## 1.0 BACKGROUND

- 1.1 This School Travel Plan (STP) has been prepared by Robert West, in conjunction with Meadow High School to support the planning application for the development and expansion of Meadow High School at the Harefield Academy site.
- 1.2 Meadow High School provides education for SEND pupils aged 11 – 19 years and is currently located on Royal Lane, Uxbridge within the LBH. The school currently has 257 pupils on the school roll. The school was recently subject of a Department for Education (DfE) project which is almost at completion.
- 1.3 Harefield Academy is a secondary school with a sixth form located 9.2km to the north of Meadow High School on Northwood Way, Harefield within the LBH. Harefield Academy is a comprehensive secondary school with a sixth form for pupils aged 11 – 18 years. It has current school roll of 317 pupils and 52 staff.
- 1.4 The development proposals are to provide an expansion of the existing Meadow High School at Royal Lane to a satellite provision at the Harefield site on Northwood Way. The existing unused boarding block at the Harefield Academy will be repurposed and a two-storey extension will be constructed to provide new SEND facilities for Pathway 1 pupils (pupils with the greatest cognitive needs) at Meadow High School.
- 1.5 Demand for pupil places at existing Meadow High School has increased and further development to accommodate this demand cannot be facilitated at the existing Meadow High School on Royal Lane. Therefore, new SEND facilities are proposed at the Harefield site for 90 pupils and 45 staff.
- 1.6 Bronze Accreditation through the Transport for London (TfL) STARS system is the aim of the School Travel Plan. The School Travel Plan template has been designed to be consistent with the data entry for the TfL STARS system, allowing review and approval by London Borough of Hillingdon (LBH) officers.
- 1.7 In due course it is envisaged that the school will input the data into TfL STARS and will take ownership and responsibility for implementation and obtaining Bronze Accreditation beyond planning determination.

## Introduction to our site

2.2 The proposed High School site will be located at the Harefield site on Northwood Way, Harefield, UB9 6ET to the east of Harefield Academy. The school, which will provide new SEND facilities, is proposed at the Harefield site for 90 pupils pathway one pupils (pupils with the greatest cognitive needs) and 45 staff.

2.3 The site is located in a residential area and is remotely located. The site is bound by the existing Harefield Academy School to the north, Northwood Way to the west, Northwood Road to the south and east.

## Local amenities

2.4 There are a number of local amenities available within the vicinity of the school. Harefield Village centre is located approximately 800m walking distance from the school and provides access to Cafes, Pharmacy's, St Mary's Church Hall, Co-op convenience store, Harefield Hospital and Harefield Village Green. Additionally, there is a post office located on Northwood Road approximately 520m from the school.

## 3.0 AIMS AND OBJECTIVES OF TRAVEL PLAN

3.1 The aim of this STP is as follows:

*The aim of this School Travel Plan is to obtain Bronze Accreditation in the 2023/2024 School Year and maintain this going forward. This will help address transport impacts associated with the proposed expansion of the school.*

3.2 The objectives of this STP are as follows:

- i. To minimise the impact on the local community of traffic associated with staff by minimising noise, pollution and congestion.
- ii. To show a commitment to improving traffic conditions within the local area associated with the proposed expansion.
- iii. To reduce the adverse effects on health associated with increased vehicle use.
- iv. To reduce air pollution and the consumption of fossil fuels.
- v. To increase the attractiveness, and hence the proportion of journeys made to and from the site by sustainable modes, of transport such as cycling.
- vi. To reduce the cost to staff on their journey to the school by promoting alternatives that are both cheaper and more environmentally friendly.
- vii. To demonstrate commitment to promoting sustainable transport choices and reducing the traffic impact of the development on the local community.

### Transportation links

#### *Details of walking access to site*

5.2 The pedestrian network within the vicinity of the site is comprehensive and includes footways with street lighting at regular intervals.

5.3 There are a number of pedestrian crossing facilities within the vicinity of the site. These include a zebra crossing on Northwood Road to the east of the junction with Northwood Way. Additionally,

there are a number of dropped kerb crossing points with tactile paving on Northwood Way where the site is currently accessed from.

5.4 There are two Public Right of Ways (PRoW) footpaths within the vicinity of the site. Footpath U11 to the east of the site which provides a connection between Northwood Road and Jackets Lane to the northeast of the site. Footpath U12 provides a connection between Northwood Road and Newdigate Drive to the southeast of the site.

*Details of cycling access to site*

5.5 There are a lack of dedicated cycle routes within the vicinity of the site. The site is situated on the outskirts of London and is remotely located within a village, therefore lack of cycling routes is considered a typical characteristic. Although there are no dedicated cycle routes, quiet residential streets within the village providing connections to the site are considered suitable for cycling.

*Details of bus access to site*

5.6 The nearest east and westbound bus stops to the site are located on Northwood Road 175m and 250m (2–3-minute walk) to the southeast of the site. Both bus stops are provided with a flag, timetable information and a yellow bus cage.

5.7 Table 3.1 shows the frequency and destinations of the bus routes available within a 640m walking radius of the site. The frequency of the buses is based the morning and afternoon school peak hours.

*Details of rail access to site*

- 5.8 There are no London Underground (LU) stations within the vicinity of the site. The closest LU station to the site is Northwood station 3.5km to the east of the site. Metropolitan services are provided to Watford, Amersham, Chesham, Baker Street and Aldgate.
- 5.9 The nearest National Rail station is to the site is Denham station located 3.5km to the southwest site. Chiltern Rail services are provided to Gerrards Cross and Marylebone.

*Details of road access to site*

*Northwood Road*

- 5.10 Northwood Road is a two-way single carriageway road that connects from Breakspear Road North southwest to northern border of the LBH where the road transitions into White Hill to the northeast of the site.
- 5.11 The road is subject to a 30mph speed limit and is largely unrestricted within the vicinity of the site. No restrictions are present on Northwood Road to the south of the site boundary. Double yellow line restrictions present on Northwood Road to the east of the site where the road begins to bend.

*Northwood Way*

- 5.12 Northwood Way is a two-way single carriageway loop road which connects to Northwood Road to the southeast of the site. Northwood Way currently provides pedestrian and vehicular access to the site and the adjacent Harefield Academy.
- 5.13 The road is subject to a 30mph speed limit and double yellow line and school keep clear restrictions are present on the eastern side of the carriageway at the frontage of The Harefield Academy. There are no restrictions in place to the western side of the carriageway.


### Historic Travel Data

6.1 This section provides details of surveys of pupils and staff undertaken to understand modal split. The survey was undertaken in March 2022. This captured usual mode of travel only.



6.3 Preferred mode of travel was not collected at the time of the last survey. This will be collected as one of the first actions of this STP.

## Targets

6.4 STP targets are outlined in Table 6.1 for pupils and staff. Given the needs of pathway one pupils a large majority of pupils are required to travel to school via vehicular modes of transport. Additionally, the remote location of the site and lack of public transport options for staff mean they are required to travel by car to school. With the above taken into account the following targets have been set and are appropriate given the nature of the site.
