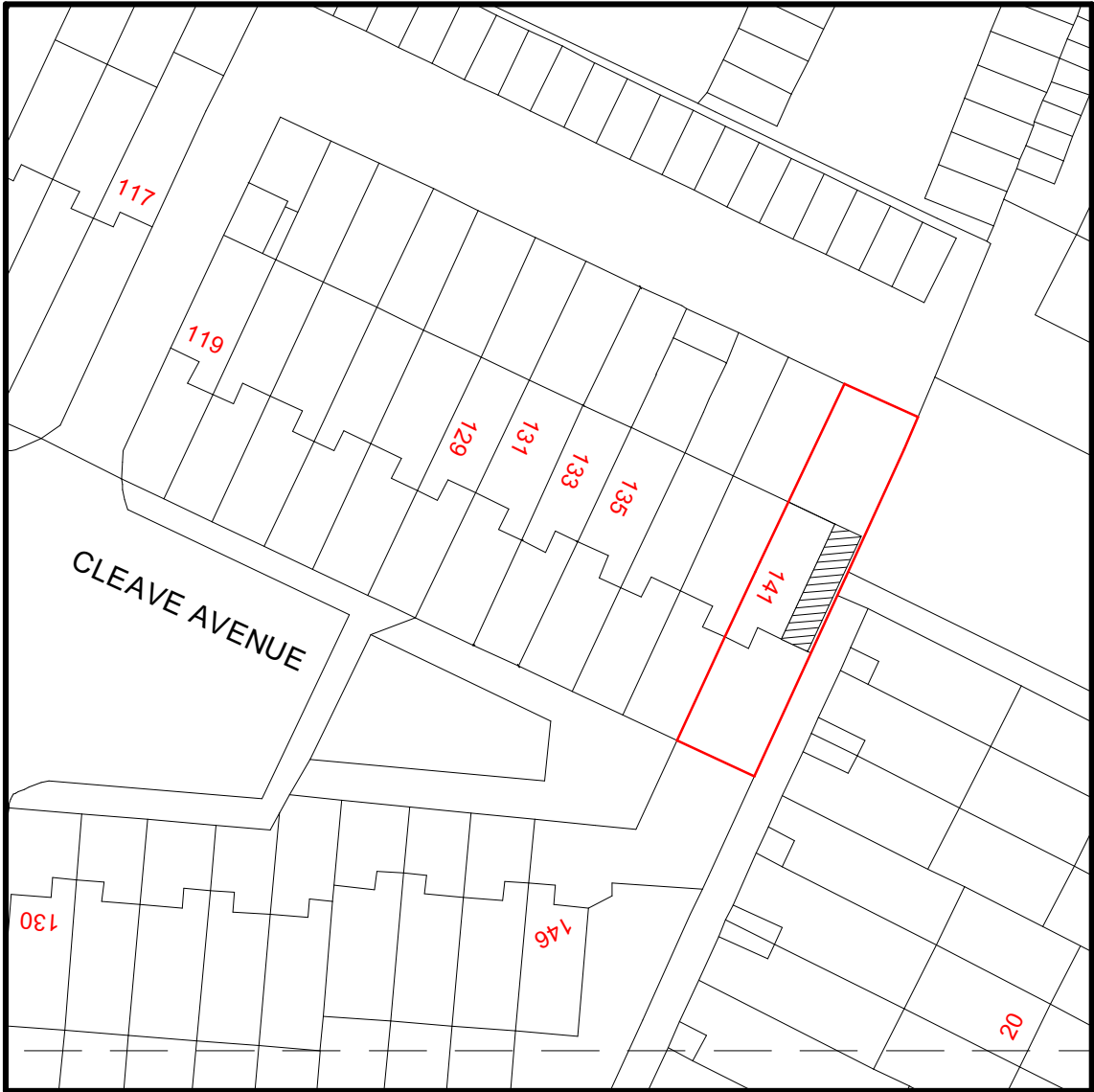
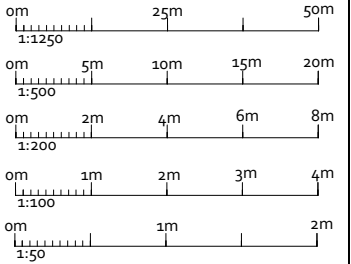




LOCATION PLAN (1:1250)

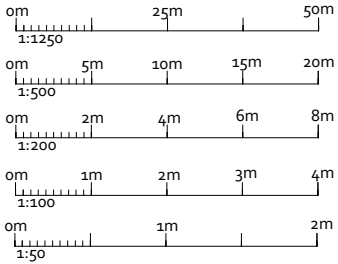
EXISTING G/F (1:100)

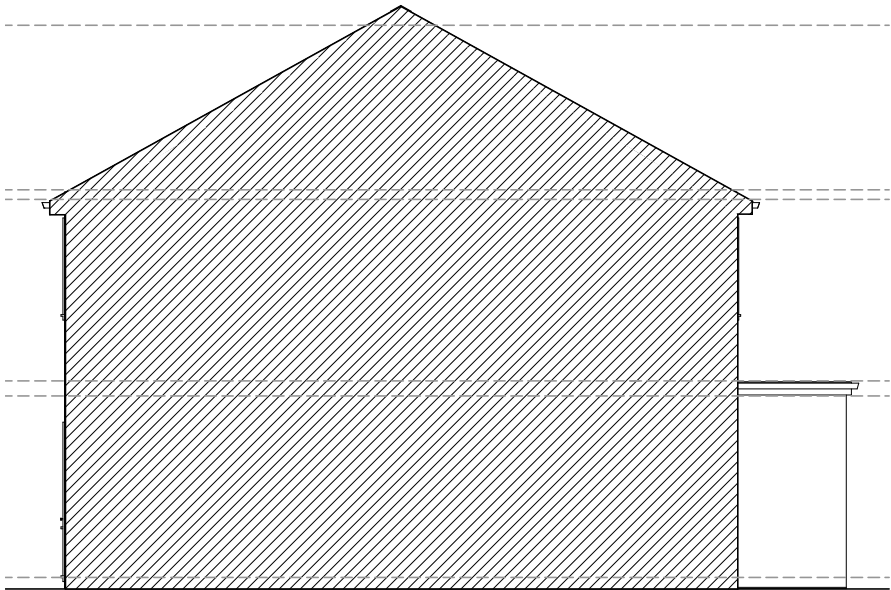
EXISTING FRONT (1:100)



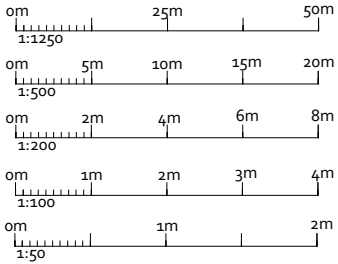
EXISTING SIDE (1:100)

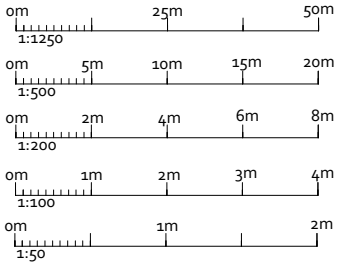
PROPOSED G/F (1:100)

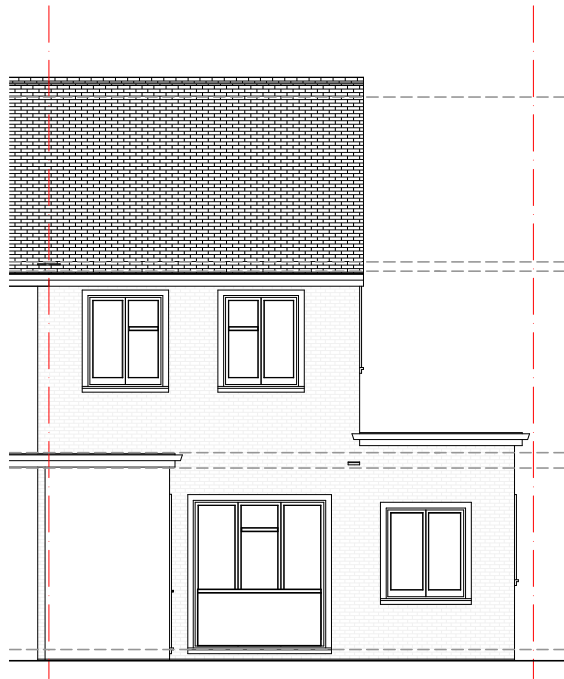

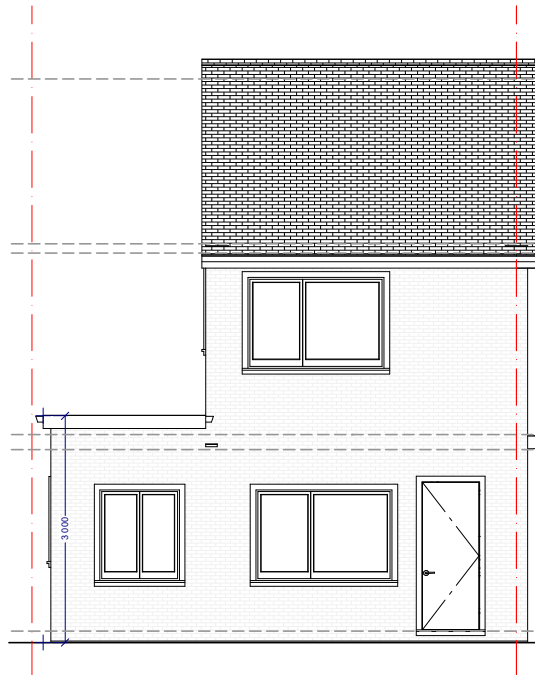

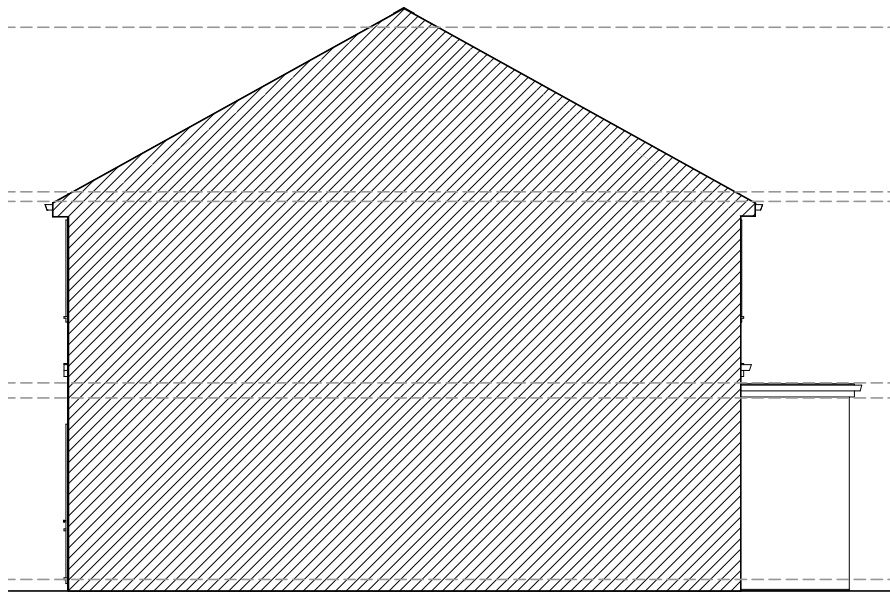
PROPOSED FRONT (1:100)



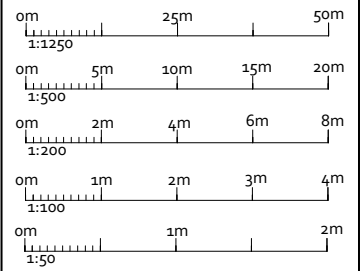
PROPOSED SIDE (1:100)
