This application seeks a Certificate of Lawfulness under Section 191 of the Town and Country Planning Act 1990 to confirm that the use of the property at 141 Cleave Avenue, Hayes UB3 4HD as a small House in Multiple Occupation (Use Class C4) is lawful.

The application demonstrates that the change of use from a single dwellinghouse (Use Class C3) to a small HMO (Use Class C4) was implemented and has been in continuous use prior to the introduction of the Article 4 Direction in the London Borough of Hillingdon (which came into force in December 2025).

This application is not seeking to be immune from enforcement by virtue of the use being present for 10 years.

This application and the accompanying evidence has been submitted to demonstrate that the application property was converted to a HMO (C4 use) prior to the introduction of the borough wide Article 4 which removed the permitted development right to change from C3 to C4 and back again.
