The proposed loft conversion is considered lawful as the works fall within the permitted development rights for the enlargement of a dwellinghouse. The proposal comprises a rear dormer roof extension, roof alterations and associated works, with a total additional roof volume of approximately 35.94 cubic metres, which is within the applicable permitted development volume limit. The use of the property will remain as an existing residential dwellinghouse. The proposed development is therefore considered to comply with the relevant permitted development requirements, as demonstrated by the submitted plans, elevations and calculations.
