### RE-DEVELOPMENT OF HAYES BRIDGE RETAIL PARK

We are writing to seek your views in relation to the proposed re-development of Hayes Bridge Retail Park Uxbridge Road.

Hillingdon Council, in their Local Plan, designated the area as a Strategic Industrial Location ("SIL") – a protected use that promotes employment uses for employment, industry and logistics operations.

### BACKGROUND

The site currently operates as an out-of-town retail destination, providing the following retail outlets:

- Currys PC World
- Halfords
- Harveys and Bensons for Beds
- Dreams
- Office Outlet
- Argos
- AHF
- Tapi Carpets

Retail has however never been the intended use of the site, and within the Councils Development Plan, the site has been earmarked for industrial purposes since **2012**.

In response to changing market conditions there is now a requirement to develop the site for its intended commercial use.

## THE PROPOSAL



The site layout plan (below) and CGI images provide an illustration of how the site could be developed.

These show a building with a footprint of approximately 16,446 square metres and maximum height of approximately 19 metres, with a shallow, ridged roof design.

The proposed colour palette could comprise of varying shades of grey, with interest added through the incorporation of glazing and the alternating use of colour, texture and finish.

A large surface carpark is shown in close proximity to the site frontage, buffered by existing soft landscaping. The existing access off Uxbridge Road would be used to serve the proposal (and upgraded if necessary).

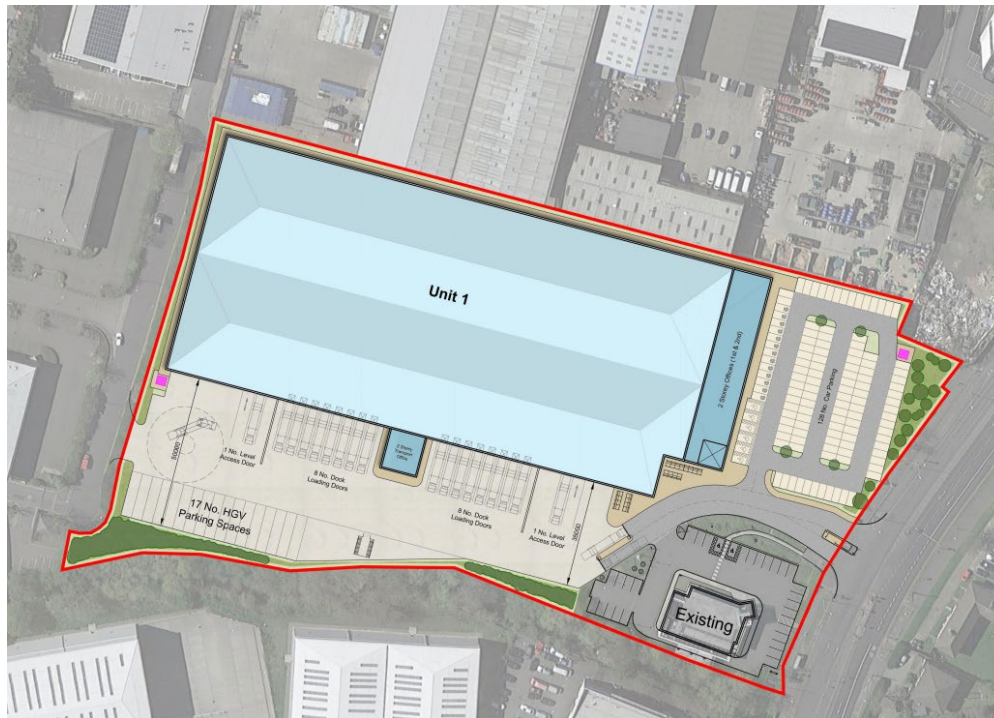
The site access would lead to a secure service yard providing HGV docking, loading and parking bays, along with a turntable to allow vehicles to exit the site in a forward gear.

Vehicle parking provision would include spaces for cars, disabled visitors, cycles and HGV's.

Soft landscaping would be retained and enhanced along the eastern site boundary and internally within the site.

The proposal would result in approximately 241 additional jobs (not including construction related employment).
