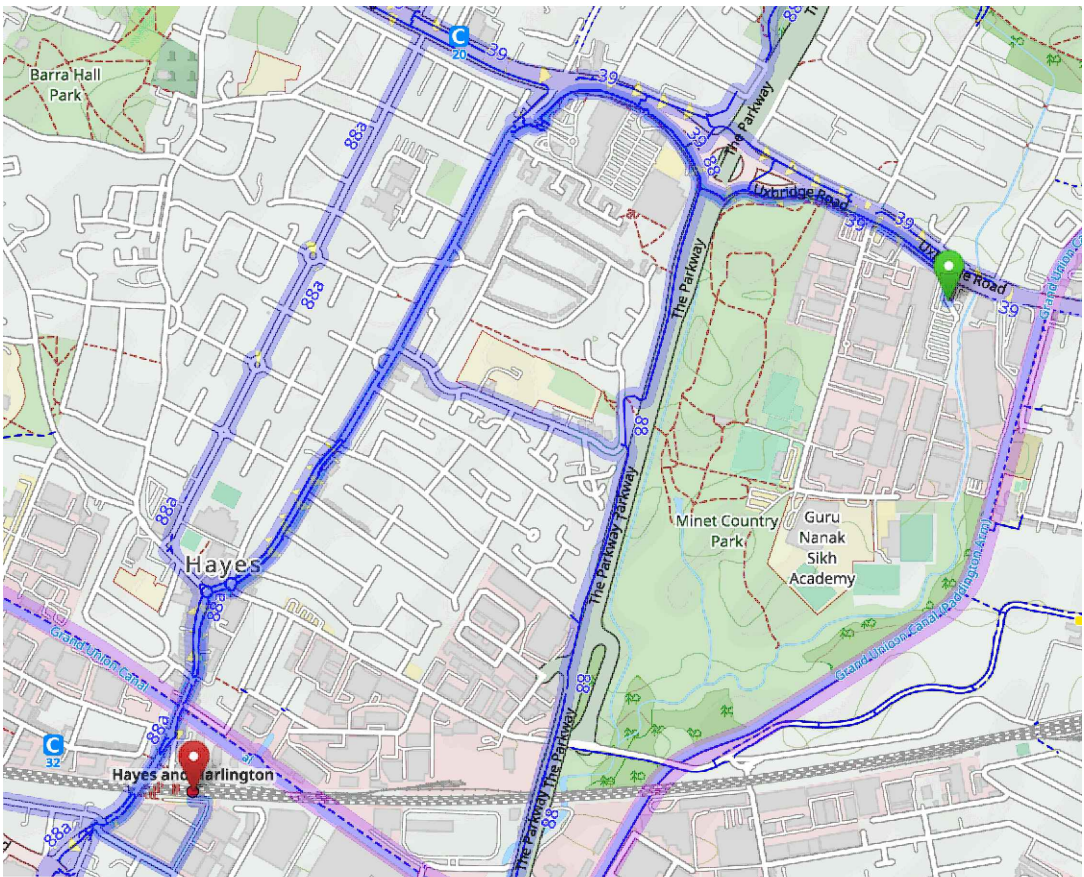


VEHICLE ROUTE TO / FROM M4

ROUTE DESCRIPTION:

- ↑ Head north-west towards Uxbridge Rd/A4020
266 ft
- ↶ Turn left onto Uxbridge Rd/A4020
0.4 mi
- ⤿ At the roundabout, take the 1st exit onto the A312 slip road to M4/Heathrow Airport/Pump Lane Industrial Est
0.2 mi
- ⤿ Merge onto The Pkwy/A312
1.1 mi
- ⤿ At the roundabout, take the 2nd exit and stay on The Pkwy/A312
0.4 mi
- ⤿ At Cranford Parkway Interchange, take the 5th exit onto the M4 slip road to Heathrow Airport/M25/Terminals 1/Terminals 2/Terminals 3/Slough
0.7 mi
- ⤿ Merge onto M4
