The loft conversion was constructed in line with the 'Permitted development rights for householders - Technical Guidance' Class B - additions etc to the roof. The hip to gable and rear dormer extension does not exceed the allowable 40m3 additional elements for a loft extension on a terrace property, the dormer is set back by 200mm from the eaves and the height of the dormer does not exceed the existing ridge line. The materials are matching to the existing also.
