Conclusion

'The proposal demonstrates positive design changes compared to the previously refused scheme, notably reducing bulk and improving articulation. While the first floor extensions are generally acceptable in principle, concerns remain regarding overdevelopment and amenity impacts from the ground floor extension (ground floor has now been removed in response to this pre-app response). Revisions should focus on ensuring the bulk of extensions is reduced, retaining the ground floor footprint as existing and ensuring a cohesive architectural approach.'
