Why do you consider that a Lawful Development Certificate should be granted for this proposal?

A previous Certificate of Lawful Development Application Ref: 19968/APP/2025/3098 was approved for the conversion of the roof space to habitable use to include rear dormer, Juliette balcony, 3x front rooflights, and erection of outbuilding to rear garden, following the demolition of the existing garage.

Planning Application Ref: 19968/APP/2025/3112 was also approved for the erection of a double storey side extension, single storey rear extension, and amendments to fenestrations.

An informative was included with this planning permission that stated:

It is noted that the site is subject a Certificate of Lawful Development Application (Ref: 19968/APP/2025/3098) which proposes "Conversion of roof space to habitable use to include Rear dormer, 3x front rooflights, and erection of outbuilding to rear garden, following the demolition of the existing garage.

The Applicant should note that both sets of extensions cannot be constructed together and may require a separate planning permission.

This revised Certificate of Lawful Development Application now takes into consideration the approved side / rear extension and to allow the construction work to be carried out at the same time.

The dormer roof of the proposed loft conversion has been reduced in size to comply with the 50 cubic meter allowance under permitted development taking into account the additional volume created by the new extension roof. Volume calculations provided.

The new dormer shall be located solely on the rear of slope of the original house.

Curtilage area is also shown on the drawings to comply for the new outbuilding taking into account the extent of previous and new extensions.
