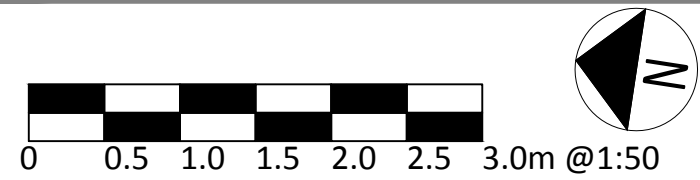
Loft Level

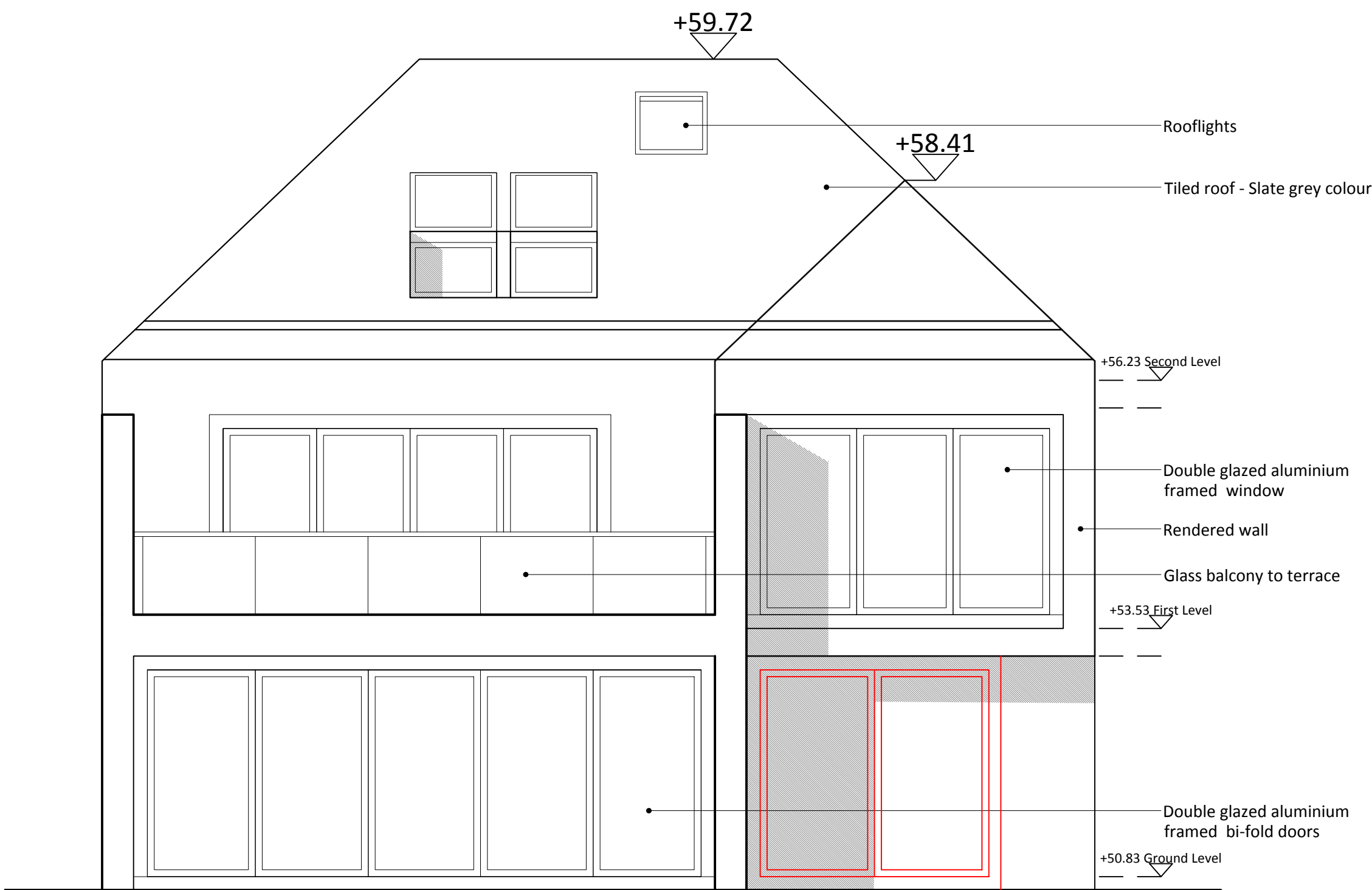

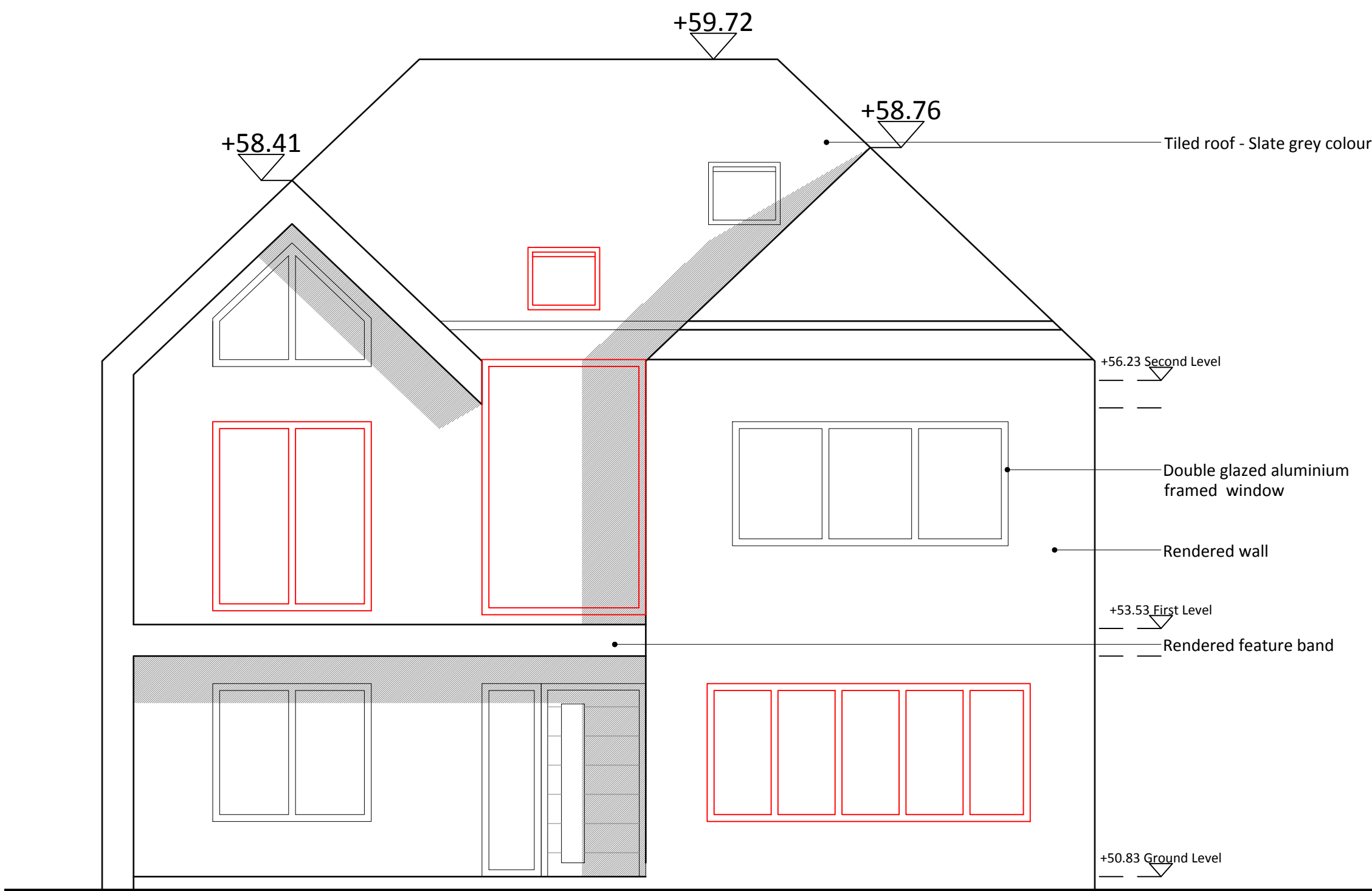

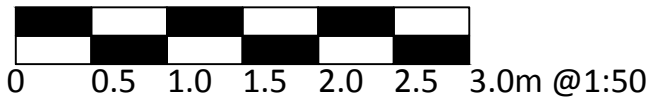
Rear Elevation

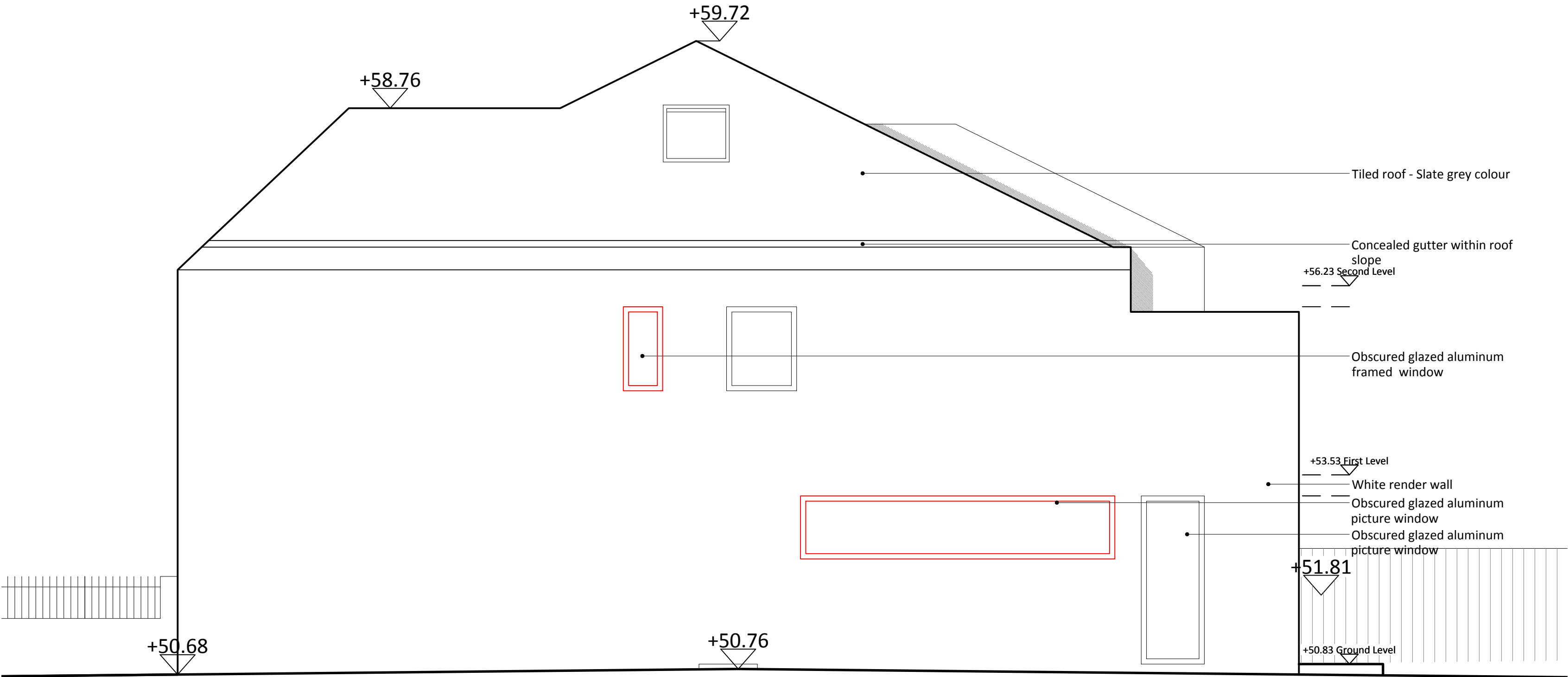

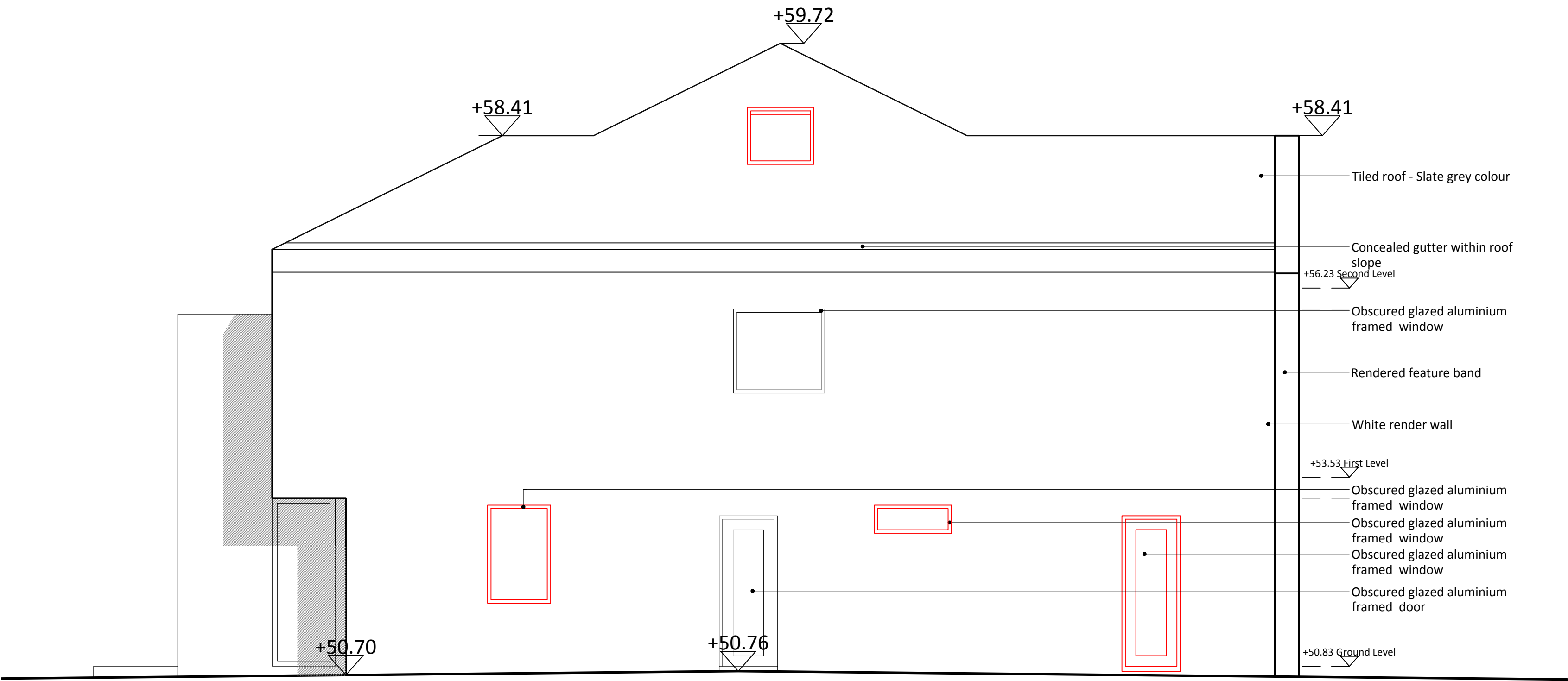

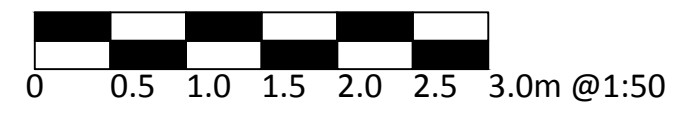
Side Elevation B
