We are seeking to vary Condition 2 (Approved Drawings) to reflect a minor amendment to the approved snug layout. The change involves squaring off the existing angled section of the snug to form a regular rectangular footprint and revising the associated door arrangement from the previously approved L-shaped bifolds to a straight set of bifold doors. The alteration results in a modest and visually discreet adjustment to the footprint, consistent with the approved roof form and overall design. No part of the proposal increases the height, massing or overall extent of the development beyond that originally approved. The amendment does not introduce any new planning impacts and remains fully in keeping with the character of the approved scheme.
