The proposal seeks to create a new opening within the existing shopfront frontage to improve the appearance, functionality, and accessibility of the commercial unit.

The development also includes the removal of the existing external extraction equipment located at the rear of the property and its replacement with a modern, enclosed light-duct extraction system designed to minimise visual impact, noise, and disturbance to neighbouring occupiers.

In addition, the proposal seeks to provide an outdoor seating area contained entirely within the boundary of the property. The seating area has been carefully designed to complement the character of the surrounding commercial environment and reflects the established café-style seating arrangements found at neighbouring premises, including the café opposite the site and the adjacent flower shop. The proposed seating will enhance the vitality and attractiveness of the local shopping parade whilst maintaining adequate pedestrian movement and preserving the visual amenity of the area.

The proposed alterations are considered sympathetic to the character of the building and the wider commercial streetscape, providing improvements to both the appearance and functionality of the premises whilst supporting the continued viability of the business.
