Thank you for your e-mail and plans.

In my opinion it looks a lot better than the recent approvals that have the two-storey rear projecting element.

The only fly in the ointment is the fact that the design guide likes two-storey side extensions to detached houses to be set-back from the front by a metre to be subordinate-see below:-

However, given the public accessway to the side I also believe the one metre set-in from the boundary is not absolutely critical and the extension does not exceed half the width of the original house.
