The proposal does not exceed the permitted development allowance of 50 cubic metres (Semi-detached property). The proposal does not exceed the height of the highest part of the roof. The proposal does not extend beyond the plane of any existing roof slope which forms part of a principal elevation of the dwelling house and fronting a highway (REFER TO 22 DERBY ROAD PRECEDENT, of which this has informed the approach to this proposal. The proposed dormer would be set in from the eaves by 1800mm, and all materials would be of a similar appearance to those of the existing dwelling. Any proposed rooflights are less than 150 mm above the roof plane.
