(TEMPORARY PROHIBITION OF TRAFFIC)
ORDER 2022

1. Transport for London hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.

2. The purpose of the Order is to enable carriageway resurfacing works to take place on A4 Great West Road.

3. The effect of the Order will be to prohibit any vehicle from:

- (1) entering, exiting or proceeding eastbound on A4 Great West Road between its junctions with Harlequin Avenue and Ealing Road;
- (2) entering, exiting or proceeding westbound on A4 Great West Road between its junctions with Syon Lane and Ealing Road

Works will be phased such that some restrictions will apply only at certain times

The Order will be effective at certain times between 7th March 2022 and 10th April 2022, every night, Sunday to Friday, from 9:00 PM to 5:00 AM or when the works have been completed, whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs

4. The prohibitions will not apply in respect of:

- (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
- (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.


5. At such times as the prohibition is in force an alternative route will be indicated by traffic signs.

For eastbound traffic traveling on
A4 Great West Road: Syon Lane, London Road, High Street, Ealing Road to normal route of travel


For westbound traffic traveling on
A4 Great West Road: Ealing Road, High Street, London Road, Syon Lane, Great West Road, Bath Road, The Parkway to normal route of traffic.
